Rotomac owner Vikram Kothari arrested by CBI

PRESS TRUST OF INDIA New Delhi, February 22

THE CBI ON Thursday arrested Rotomac owner Vikram Kothari and his son Rahul, both directors in the company, for alleged default on loan repayments to the tune of ₹3,695 crore, officials said in New Delhi.

Kothari, who was called at the agency headquarters here for questioning, and Rahul were not cooperating in the investigation that led to their arrest, they said.

A consortium of seven nationalised banks has given bank loans worth ₹2.919 crore from 2008 onwards to Rotomac Global, the CBI FIR has alleged.

The amount swelled to ₹3,695 crore, including the accrued interest, because of repeated defaults on payment, the officials said.

Parrikar presents ₹17,123-cr Goa budget



GOA CHIEF MINISTER Manohar Parrikar on Thursday presented in the state assembly a ₹17,123-crore budget for 2018-19, an increase of 6.84 per cent over the ongoing fiscal, with a stress on education and job creation.

Parrikar, who was undergoing treatment at a Mumbai hospital for a pancreatic ailment, returned to Panaji this afternoon. The chief minister was present in the assembly complex for half an hour,

during which he chaired a meeting of his Cabinet, tabled the budget and witnessed the passage of vote-onaccount for five months. The budget session was curtailed to four days owing to Parrikar's ill-health.

In his speech in the House which lasted only five minutes, Parrikar said he could not present an elaborate budget because of his ill-health but would make a supplementary statement before the end of the current financial year. The gross total budgetary expenditure is ₹17,123.28 crore for the coming fiscal,against ₹16,027.01 crore for 2017-18, a 6.84% hike.

Youth holds cop by the collar

A police constable who stopped a youth for allegedly misbehaving in public had to face his wrath as the latter allegedly held him by his uniform collar. Strangely, instead of whipping the youth for his temerity to take on the sentinels, the authorities at the police station released him on station bail in no time.

Nitish G, a constable attached to Ashokapuram station, was on his beat near the family court at Jayanagar here at 7 pm on February 21, when twoscooter borne (Honda Activa) youth were found moving in a reckless speed.

The pillion rider, later identified as Karthik, aged 21 years, from the same locality had stretched his arms wide, on the busy road, where girls were passing by Nithish who found it arrest formalities, people

absurd, somehow succeeded in stopping the vehicle. When he questioned Karthik for his indecent behaviour, he took him to task for questioning him and also held by his collar. "You don't know who I am," said Karthik warning Nithish not to cross sword with him.

Even as the passersby

gathered, Karthik went on to unleash choicest of words against Nithish. Even when Nithish tried to pull out his cellphone at least to capture the rider on the camera, the latter identified as Darshan too tried to snatch the same. It was then Nithish informed Garuda police patrolling personnel who arrived on the spot. By then the rider took to heels leaving behind the vehicle that actually belongs to Karthik.

No sooner Karthik was brought to station to fulfil mostly believed to be his father's friends trooped in from nowhere. Even as a first information report (FIR) was filed charging him with restraining a government servant from performing his duties under section 353 of IPC, he was subsequently released on station bail.

Karthik who is believed to be the son of the president of a cooperative society, studies in a city college. He is also associated with one Rocky who is a rowdysheeter in the same police station limits.

According to sources, 'in no such cases in the past, at least in Mysuru, the accused was released on station bail. While there is a provision to release the accused only on instructions of investigation officer (IO). In such cases, the accused are released on bail only by court.

Baseline survey of Jenu Kurubas, Koragas launched in Karnataka

KARNATAKA State Tribal Research Institute (KSTRI) has launched a baseline survey of Koragas and Jenu Kurubas who are classified as Particularly Vulnerable Tribes (PPT). The first of of its kind survey is intended to create a data bank about the population, health and socio-economic conditions of these tribes which in turn help the government properly plan and implement schemes and programmes for their

Date collectors are going door-to-door of Koragas in Udupi and Dakshina Kananda districts and Jenu Kurubas in Mysuru, Chamarajanagar and Kodagu districts from last one month to collect the

KSTRI director Dr Basavanagouda T said about 20 data collectors who are graduates or post graduates are pressed into the exercise and the survey is planned to be completed in six months time.

He said no such survey was conducted in pre or post Independent India. Though central and state governments have several schemes for these tribes, no significant changes were witnessed in their conditions.

Their haadis and colonies speak volumes about it. In the backdrop of this, he said the Centre has ordered for the survey

and the accurate data of various aspects concerning these tribes will help government make proper budgetary allocation for their welfare schemes and programmes and also implement it in a systematic

Hitherto, the welfare programmes for these tribes were carried out based on their population figures available from census. But sources said the welfare schemes were not reaching many genuine beneficiaries as the census had under reported their figures. "Generally, these tribal people live in haadis located on the fringes of forest and the census enumerators do not take their count seriously," said

Basavanagouda said based on the specific data available from the survey, KSTRI will create a report for the comprehensive development of Koragas and Jenu Kurubas, which will be submitted to the Centre.

However, the director said the data collectors are facing some challenges in course of their work. "Since their conditions have not turned better despite many NGOs carrying out a lot of such surveys in the past, the tribals are not keen to give inputs for the data collectors.

Hence, we have enrolled some graduate tribals too as date collectors to convince them," added Basavanagouda.
