Re: Scrutinizers' Report on remote e-voting and voting by poll at the EOGM of JSL Industries Limited held on 20th February, 2018.

- 1. I, J. J. Gandhi, Proprietor of J J Gandhi & Co. - A. As per requirement of Rule 20(v), the Public Advertisement with respect to dispatch of EOGM Notice and intimating date and time of commencement and closing of E-voting have been published in English language in the newspaper In
- B. dian Express dated 25th January, 2018 and in Gujarati language in the news paper Financial Express dated 25th January, 2018.
- C. The e-voting period remained open from **17th February**, **2018** (9.00 A.M.) to **19th February, 2018** (5.00 P.M.).
- D. The Members of the Company holding shares in physical form or demat form as on "Cut-off" date i.e. 13th February, 2018 were entitled to vote on the resolutions mentioned in the Notice of EOGM.
- E. At the EOGM Poll was conducted to facilitate the members/ proxies present at the EOGM and who did not vote in the E-voting process.
- F. Ballot papers were given to the Members and proxies present at the meeting. The empty ballot box was shown, locked and sealed in my presence and in the presence of members and proxies.
- G. Subsequently, the ballot box was opened in my presence and in the presence of CS Sonal Shimpi and CS Sakhishree Padaria who are not in the employment of the Company. They have signed at the end of report to confirm that polling box was opened in their presence.
- H. The poll papers were scrutinized and reconciled with the records maintained by the Company/ Registrar & Transfer Agent and the authorizations/ proxies lodged with the Company.
- I. The poll papers, which were incomplete and/ or which were otherwise found defective, if any, have been treated as invalid and kept separate.
- J. After counting votes cast through poll at the EOGM, the E-votes cast were unblocked on 20th Dec., 2018 in the presence of two witnesses CS Sonal Shimpi and CS Sakhishree Padaria who are not in employment of the Company. They have signed at the end of report to confirm that the e-votes have been unblocked in their presence.
