## ती तो गरीबों को लाभ मिलेगा : योगी

है।' उन्होंने यह भी कहा कि त्रिपुरा लोगों को केंद्र सरकार की प्रमुख योजनाओं जैसे प्रधानमंत्री मुद्रा योजना, स्टैंड अप इंडिया, स्टैंड अप योजना, नमस्त्री उज्वला योजना सहित अन्य योजनाओं के लाभ से वंचित किया गया। त्रिपुरा में 60 सदस्यीय विधानसभा के 18 फरवरी को चुनाव होगा और ग्राम की घोषणा तीन मार्च को की जाएगी। आदित्यनाथ ने यह भी आरोप लगाया कि त्रिपुरा के मुख्यमंत्री मानिक साह और उनके सरकार की विकास कोई रूचि नहीं रही जबकि केंद्र ने शिक्षा, स्वास्थ्य और अन्य महत्वपूर्ण क्षेत्रों लिए भारी कोष आवंटित किया। उन्होंने कहा कि सत्तारूढ़ माकपा त्रिपुरा सरकार को बढ़ावा दे रही है और यह स्पष्ट है कि उसे विधानसभा चुनाव सत्ता से बेदखल करना जरूरी हो गया। आदित्यनाथ ने कहा, 'राज्य में बेहतर शिक्षण के लिए एकमात्र विकल्प भाजपा हो सकती है।' उन्होंने आरोप लगाया कि त्रिपुरा में कानून व्यवस्था पूरी तरह से खराब हो गई है और सरकार सत्ता में बने रहने का अधिकार खो चुकी है।
