New Delhi, India — February 09, 2018 — GE T&D India Limited – a GE Group Company, reported on 07 February 2018 its financial results for the third quarter ended 31 December 2017

For the third quarter ended December '17

- Total sales revenue was INR 14.4 Billion, growth of 18% compared to Quarter Ended (QE) December '16.
- Operating profit (profit before interest and tax) was at INR 1.3 Billion, growth of 30% against 1.0 Billion in QE December '16.
- Net Profit After Tax increased to INR 717 Million, against net profit of 443 Million in QE December '16
- New order bookings were INR 7.8 Billion.
