## MANIFESTO BUDGET

Hence impact on exchequer is perhaps not very high. As such, India's expenditure on health and education as a proportion of GDP is much smaller than its peers. Nevertheless, this is a first step toward provision of universal health insurance, and should be welcomed. Of course merely providing health insurance financing would not suffice, unless accompanied by substantial increase in healthcare facilities like beds, hospitals and doctors. The focus on health and education is to be seen as enhancing India's human capital. Hence expenditure on teachers and doctors' salaries should not be counted as revenue spending, but rather capital spending. India's demographic potential cannot be fully realized without enhancing human capital - i.e. raising the level or skilling, education and training as well as health.

**LONG TERM CAPITAL GAIN TAX:** One significant and welcome step was the reintroduction of long term capital gains tax after a gap of almost 21 years. The LTCG, which escaped taxes, was estimated to be about 3.7 lakh crore last year. LTCG accrues mostly to the higher income classes. Also a tax on LTCG is a direct tax, unlike GST which is an indirect tax, like excise on petrol and diesel. Indirect taxes tend to be regressive and hurt the poor disproportionately. The ratio of indirect taxes in total taxes of India had been going up steadily in the last three years. Hence it is good that LTCG has been introduced. The setback to the stock market will hopefully be temporary. The government overachieved its disinvestment target which is quite impressive. But this was done partly by the left pocket buying from the right pocket. The other non-tax revenue from the spectrum fees and auctions, as also dividend from the RBI has been falling. So next year's target is only modestly higher, and achievable. For the urban middle class there is not much to cheer. But then the growth boost from increase in the rural purchasing power will benefit the urban class indirectly. The focus on social sectors like health, education and the elderly is welcome. The other priorities like job creation or boost to exports and manufacturing have each got some support, but nothing is as big an initiative as the universal health insurance. With some luck the global macro environment is favourable (despite rise in oil prices). This can induce better growth in exports and manufacturing in India, and that can support growth of around 7.5 percent. Such an outcome, would be a validation of the growth inducing effect of the budget.

release, the gesture did not pay off as the party lost the Ajmer seat that has a sizeable population of Rajputs.

The recent incidents of vigilantism in the name of cow protection, including the lynching of a Muslim man Pehlvi Khan in Alwar over allegations of cow smuggling, appeared to have led to consolidation of the minority community behind the Congress.

Numbers tell the tale: While Karan Singh Yadav of the Congress trounced his nearest BJP rival Jaswant Yadav by a whopping 196,496 votes in Alwar, the main opposition party's nominee for Ajmer, Raghu Sharma, beat BJP's Swaroop Lamba by an impressive margin of over 84,414 votes. The Congress won the Mandalgarh Assembly seat by nearly 13,000 votes. Rebel Congress leader Gopal Malviya, who contested as an independent, failed to alter the outcome.

The BJP had won all the 25 Lok Sabha constituencies in the state in the 2014 general elections.

Buoyed by the results, a jubilant Congress president Rahul Gandhi hailed the party's Rajasthan unit for its impressive show, calling the outcome a "rejection" of the BJP by the people.

## Rs 51, 000 cr for city alone

As part of the Railways' redevelopment plan, escalators will be provided at stations all over the country with passenger footfalls above 25,000. Also, all railway stations and trains will be provided with wi-fi facility for information and entertainment. This will enable people in rural areas, including women and youth, to access the internet.

Mumbai's commuters are hopeful that city stations would be part of this ambitious plan. "Some stations are in dire need of upgrade, as infrastructure is in a poor shape. If escalators are being promised at all stations that have footfalls more than 25,000, every station in the city should be getting one," said Asif Khan.

The suburban network, used by around 8.50 million commuters daily, will also be expanded with another 150 km of railway lines to be laid at a cost of Rs 40,000 crore, which will for the first time include elevated corridors in some sections of the space-starved city.

WR Chief Spokesperson Ravinder Bhakar said funds have also been allocated for India's first Rail & Transportation University, proposed to come up in Vadodra, Gujarat. The university will be equipped with facilities for training manpower for the ambitious Mumbai-Ahmedabad Bullet Train project coming up with Japanese collaboration.

All the three specific proposals - escalators, WiFi and CCTV - are already under implementation in Mumbai and at various major suburban stations for the past couple of years and will get a further boost with this year's budget, officials said.

However, not everyone seemed impressed. "While a host of ideas have been proposed, these suggestions were also made in last year's Budget," said yet another Railway official.

## Senior citizens a happy lot

citizens and very senior citizens (aged 80 and above) has been increased to Rs 50,000 under Section 80D of IT Act. Expenses incurred on critical illness by senior citizens will also be exempt up to Rs 1 lakh. Earlier, it was Rs 60,000 for senior citizens and Rs 80,000 for very senior citizens.

Digambar Chapke, president of AISCCON, said around 30 per cent of the senior citizens across the country live alone. "There are around 10 lakh elderly in Mumbai itself. If they are empowered and benefit from this move, it instills confidence in them, especially octogenarians," Chapke added.

The increase in tax exemption limit for interest income for senior citizens will be a big relief as this category derives most of its income from bank FDs and post office schemes. The increase in tax breaks for insurance and medical expenditure is also beneficial. The minister also proposed to extend Pradhan Mantri Vaya Vandana Yojana up to March 2020 and increased the limit to Rs 15 lakh per senior citizen.

He did not elaborate what will be the new emoluments of the MPs but said the new law will determine the salary, constituency allowance, office expenses and meeting allowances payable to the MPs with effect from April 1, 2018. Though he was silent on the ex-MP's pension, sources said it would be also part of the proposed Bill.

## Imports made costlier...

fruit juice from 30 to 35%, other fruit juices and vegetable juices 30 to 50%, Cranberry juices 10% to 50%, miscellaneous food preparations (except soya protein) 30% to 50%, perfumes, beauty or make-up or hair preparations, preparations for oral or dental hygiene and pre-shave, shaving or after-shave preparations, personal deodorants, bath preparations and other perfumery, cosmetic or toilet preparations 10% to 20%.

The custom duty hike is from 7.5% to 15% in case of accessories of motor vehicles and motor cycles, from 10% to 15% in case of CKD import of motor vehicles, cars or motor cycles as also truck and bus radial tyres, and 20% to 25% CBU imports of motor vehicles. The duty in silk fabrics as also footwear is hiked from 10% to 20% and 10% to 15% in case of parts of footwear.

The duty is doubled on cut and polished coloured gemstones and diamonds from 2.5% to 5% while the hike on imitation jewellery is from 15% to 20%.

In case of furnitures, including seats and parts of seats, mattress support, articles of bedding and furnishing and light fitting will attract the custom duty of 20% instead of present 10%.

A host of other items on which the customs duty is double from 10% to 20% are: wrist watches, clocks, alarm clocks, toys like tricycles, scooters, pedal cars, dolls, doll carriages, puzzles of all kind, video game consoles, parlour games, automatic bowling alley equipment, festive, carnival or other entertainment articles, articles and equipment for sports or outdoor games, swimming pools, fishing rods and nets, and shooting galleries and other fairground amusements.

The miscellaneous items on which the duty is doubled to 20% include sunglasses, kites, date, sealing or numbering stamps, cigarette lighters, scent sprays and toilet sprays while it is raised from 10% to 25% in case of candles and the like.

The customs duty has been also hiked on the edible vegetable oils. It is 30% instead of 12.5% on the crude oils like groundnut oil, olive oil, cottonseed oil, safflower seed oil, saffola oil, coconut oil, palm oil, linseed oil, castor oil and sesame oil while it is 35% instead of 20% in case of these refined oils.

In case of refractory items like bricks, blocks, tiles and similar ceramic construction goods, the duty is increased from 5% to 7.5% while it is reduced from 10% to 7.5% in case of stone articles of magnesite, dolomite or chromite, bricks, blocks, tiles and other ceramic goods of siliceous fossil meals or similar siliceous earths.

Jaitley also brought in 10% social welfare surcharge on the aggregate duties of customs on the imported goods and another 3% surcharge on a host of goods. He was quite frank that he was making a calibrated departure from the policy in the last two decades to reduce the customs duty.

He, of course, did reduce some of the customs duties in the name of ease of doing business in the cross-border trade and to meet commitments under the trade facilitation agreement.

## Where is the money, Honey? FM unfazed

is 1.5 times the production cost. The finance minister revealed this during a talkshow after his budget presentation, in which he answered the questions of the general public.

"I think both MSP and healthcare can be supported only out of the long term capital gains taxation," he said in response to a question on the need to tax capital gains at a time when the government is trying to attract more investments.

But he refused to speculate how much money will be required to fund the scheme. He said that the idea was mooted by the NITI Aayog, which had done a detailed study into universal healthcare. "We have started by making it available to 10 crore families on the bottom ladder," he said, hinting that if the scheme succeeds, it could later grow into a universal healthcare system. The imposition of this new tax, Jaitley believes, would not add to the burden of the middle class. "Most of the beneficiaries no tax on long-term capital gains were the wealthiest. This was a subsidy for the richest," he said, adding that the government decided to divert this "subsidy" from the richest for healthcare and to pay farmers the MSP.

## Are the Budget targets doable?

Now it is well known that one major reason for low workforce participation rate is the burden of unpaid work (care of children, disabled, old and chronically sick as well as domestic services); however this is not at all addressed by the budget.

There is no doubt that distribution of LPG gas cylinders at reduced price to poor women does help. But not to the poorest women who cannot afford refilling the cylinder. Studies have shown that LPG gas cylinder is welcome when women earn equal or more money. There are many women who do not earn enough or no cash, need cheaper fuel, such as fuels like kerosene and smokeless stoves.

Again, women also need universal child care to reduce their burden of work. In fact, professional care to disabled and chronically sick as well as universal child care will go a long way to increase their participation in the labour market and in skill training and education. Without reducing the burden of unpaid work, women should not be given employment. After all, one of the reasons for their widespread malnutrition is the excessive burden of work and time stress, arising from their paid and unpaid work.

Many of the new programmes included in the budget also need sound support from old and new institutions. The budget has not addressed this aspect. Uplift of SC/ST population has been a goal frequently repeated by all governments in India in the past. However, this population has remained more or less excluded from the gains of development through generations. It is now realized that the SC/ST population is different from the poor; in general, the government has not recognized this adequately in the past and in this budget. They need a different strategy.

Finally, as regard jobs, which is an urgent priority of the economy, the government assumes that all beneficiaries of MUDRA scheme are employed, which is far from the truth. The rate of mortality of such schemes has been quite substantial. Also, the sustainability even of short term successes is very low, as they need continuous flow of credit, continuous access to technical and professional services, forward and backward linkages with the regional economy and strong marketing to remain in the market for long. There are positive points in this scheme, but the FM is expecting too much from it. Mere refinancing facility is not adequate, what is needed for support for long term sustainability. The budget has given good ideas, but not taken care of some critical questions. Unless these questions are addressed, the budget has limited use for the economy.
