PRESS RELEASE

It has come in a section of media that Canara Bank has filed a complaint with CBI on fraudulent transactions worth Rs.515 crores against Kolkata based RP Infosystems and its directors. In this regard, we wish to clarify as follows:

Under the consortium arrangement of 17 banks, Canara Bank financed a Working Capital limit of Rs.40 crores (4.69%). We were NOT the leader of the consortium. The leader Bank had already filed a case with CBI in May 2015. The account had already been treated as fraud by our Bank during October 2015 and reported to RBI.

Consequent upon the leader bank relinquishing its role as the leader of the consortium and as directed by CBI (BS&FC), Kolkata, we were authorized by the remaining member banks to file revised complaint with CBI which we have filed on 26.02.2018.
