- 1. We have reviewed the accompanying statement of Unaudited Standalone Financial Results of Ramco Industries Limited ("the Company") for the quarter and nine months ended 31st December, 2017 ("the Statement") being submitted by the Company pursuant to Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, as modified by Circular No. CIR/CFD/FAC/62/2016 dated 5th July, 2016. This statement is the responsibility of the Company's Management and has been approved by the Board of Directors. Our responsibility is to issue a report on these Financial Statements based on our review.
- 2. We conducted our review in accordance with the Standard on Review Engagement (SRE) 2410, 'Review of Interim Financial information performed by the Independent Auditor of the Entity', issued by the Institute of Chartered Accountants of India. This standard requires that we plan and perform the review to obtain moderate assurance as to whether the Financial Statements are free of material misstatement. A review is limited primarily to inquiries of Company personnel and analytical procedures applied to financial data and thus provide less assurance than an audit. We have not performed an audit, and accordingly, we do not express an audit opinion.
- 3. The unaudited standalone financial results for the Corresponding Quarter and Nine months ended 31st December 2016 and the audited financial results for the year ended 31st March 2017 included in the Statement, were reviewed/audited by the predecessor auditors, whose limited review report dated 7th February 2017 and audit report dated 30th May 2017 expressed an unmodified opinion on those unaudited/audited standalone financial results respectively.
