- d) He shall pay the amount of fees for registration in the manner provided in the Securities and Exchange Board of India (Stock Brokers and Sub-Brokers) Regulation, 1992;
- e) He shall take adequate steps for redressal of grievances of the investors within one month of the date of the receipt of the complaint and inform the Board as and when required by the Board;
- f) He shall at all times abide by the Code of Conduct as specified in Schedule II;
- g) He shall at all times maintain the minimum net worth as specified in Schedule VI of the Securities and Exchange Board of India (Stock Brokers and Sub-Brokers) Regulation, 1992; and
- h) You shall ensure compliance with the provisions of AML circulars issued by SEBI which require furnishing of prescribed reports to FIU-IND and you shall also mandatorily get registered with FIU-IND through FINnet Gateway.
- 4) You are hereby informed that you are allowed to buy, sell or deal in securities only in the name and style written in the certificate enclosed and not in the names of your Directors who may be members of the Stock Exchange.
