Genus Power Infrastructures Ltd, has won an order for supply, installation, shifting & commissioning of ~30,000 3Q meters, LT CT & HT meters with accessories including generation of first bill cycle & other incidental services. The value of the order is pegged at ~Rs. 125 Crores.

We have won an order under the government schemes - Deendayal Upadhyay Gram Jyoti Yojna (DDUGJY) and Integrated Power Development Scheme (IPDS). The meters are to be installed at CESU, NESCO, SOUTHCO and WESCO utility in Odisha on turnkey basis.
