Mr. D.K. Jain, who has turned 75 Years on 08th November 2017, will retire from the Board of Directors of the Company after a long association as the founder Member of the Board and will relinquish his position as Chairman and Member of the Board w.e.f. 31st March 2018.

He will continue to guide and support the Company to ensure continuous growth and expansion in future and will also pursue his philanthropic interests.

The Board Members discussed this subject at length and reluctantly accepted Mr. Jain's decision and appointed him to be the Chairman Emeritus and Chief mentor to the Board with w.e.f. 1st April 2018 and extended invitation to attend the Board meetings of the Company, which he graciously accepted.

The Board also documented that under Mr. Jain's guidance, the Company became a dynamic player in the auto component sector, establishing a global reputation for high ethics and a trusted partner with Stanley Electric Co. Ltd, Japan. The Company has established long standing relationship with major Auto OEMs.
