THE PERIOD FROM 1ST JULY 2017 TO 30TH SEPTEMBER 2017.**

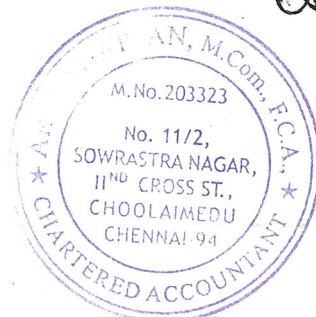
