# Cong winning Twitter battle but not matching BJP on WhatsApp

The battle for the Karnataka Legislative Assembly is being fought as much on social media as in cities and villages of the state. While the Janata Dal (Secular) has struggled to make its presence felt in the virtual world, self-goals have marred the effort of the Congress and Bharatiya Janata Party (BJP).

The BJP and Congress social media chiefs, respectively Amit Malviya and Divya Spandana, are currently stationed in Bengaluru, trying to build a narrative in favour of their parties.

There have been repeated bloopers in the BJP campaign, including when BJP chief Amit Shah described the earlier BS Yeddyurappa-led BJP government as the most corrupt Karnataka ever saw. He had meant to say it was the Siddaramaiah-led Congress government that had been the most corrupt.

Some of the Congress social media messages, particularly when it ridiculed the Prime Minister for his "hugopolitancy" during the visit of the Israeli PM, have been criticised not by the BJP but within the party as well.

If the Congress has found success in scoring over the BJP on Twitter and Facebook, it has failed to match the Sangh Parivar's finesse at

utilising WhatsApp as a primary medium to send its message across. The BJP and Sangh Parivar, honed their WhatsApp outreach in the Uttar Pradesh and the Gujarat assembly polls, making the medium an effective campaign tool at the polling booth level.

# Asaram gets life term for rape of minor

Jodhpur, 25 April

A Jodhpur court on Wednesday awarded life sentence to self-styled godman Asaram after holding him guilty of raping a teenage girl in his ashram five years ago, the second case of a powerful spiritual leader being convicted of a sexual offence in less than a year after Dera Sacha Sauda head Gurmeet Ram Rahim last August.

Special Judge Madhusudan Sharma's verdict, which comes as the debate over sexual violence, particularly the rape of minors, intensifies across the country, was read out in the Jodhpur Central Jail where 77-year-old Asaram has been kept for over four years.

The special court for SC/ST cases convicted two other accused, Shilpi and Sharad, and acquitted two, Prakash and Shiva.

"The court has awarded life imprisonment to Asaram while the two other convicts have been each sentenced to 20 years in jail," a senior police official said.

Arguments for the quantum of sentencing were earlier held inside the heavily fortified jail premises, where the trial court delivered its verdict in accordance with the directions of the Rajasthan High Court. Asaram, who started from a hut on the banks of the Sabarnai, created a 4000-billion empire with other parts of the world in four decades.

The charge sheet against Asaram and the four other accused was filed by the police on November 6, 2013 under various sections of the POSCO (Prevention of Children from Sexual Offences) Act, the Juvenile Justice Act and the Indian Penal Code.

# SC questions Centre on mandatory seeding of Aadhaar with mobile

The Supreme Court on Wednesday raised questions over the government's decision ordering mandatory seeding of mobile numbers with Aadhaar, and said its earlier order on mandatory authentication of the users was used as a "tool".

A five-judge Constitution Bench headed by Chief Justice Dipak Misra, hearing a clutch of petitions challenging Aadhaar and its enabling 2016 law, said its order on a PIL filed by Lokniti Foundation had said that mobile users needed to be verified in the interest of national security.

"In fact there was no such direction from the Supreme Court, but you took it and used it as a tool to make Aadhaar mandatory for mobile users," the Bench, also comprising Justices A.K. Sikri, A.M. Khanwilkar, D.Y. Chandrachud and Ashok Bhushan, said.

Senior advocate Rakesh Dwivedi, appearing for the Unique Identification Authority of India (UIDAI), said the Department of Telecommunication (DoT) notification talked about re-verification of mobile numbers by using e-KYC process and the Telegraph Act gave "exclusive power to central government to decide license conditions" of service providers.

"How can you (DoT) impose condition on service recipients for seeding Aadhaar with mobile phones," the bench said, adding that license agreements were between the government and the service providers.

Dwivedi said the direction to seed mobile with Aadhaar was taken in pursuance of Trial's recommendation.

Besides, the government was entitled and had legitimate state interest to ensure that a sim card is given to only those who applied, he said, seeking to allay apprehensions that the State would surveil the people 24x7.

"My submission is that the government had a legal basis to link Aadhaar with SIM by virtue of section 4 of the Telegraph Act and also, the measure is reasonable in the interest of national security," the lawyer stressed.

Dwivedi, at the outset, alleged that the Aadhaar scheme was being unfairly targeted as nobody was questioning the banks and the telecom firms on collection of information.

The banks and telecom companies have much "bigger data base" about the citizens, he said, adding, "For example, Vodafone has much bigger data base of information even without Aadhaar. The Aadhaar data is immaterial for them." "Appreciate the fact as to how much information a bank possesses about its customers.
