Sub: Disclosure under Regulation 30 -Para B of Schedule III of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Intimation about incidence of Fire breakout at Satnoor Plant of the company situated in the District Chhindwara, Madhya Pradesh at 7.30 P.M. on 29-04-2018

Under the advice of the Managing Director of company Mr. B. M. Bhansali, the undersigned would like to draw your kind attention on the subject captioned above and in connection therewith, following facts are being brought to your notice.

- (a) A fire broke out around 7.30 pm on 29-04-2018; cause whereof is yet to be ascertained.
- (b) The Fire was brought under control within a span of around one and half hours and was fully extinguished by 9.00 pm on 29-04-2018.
- (c) The Fire was confined in a single processing unit Flocculation and Drying (F&D Section). Even in this section, Flocculation, flash dryer and resin bins which are integral part of the F& D Section were not affected and the fire was localized at the fluid bed dryer equipment only.
- (d) Unfortunately there was casualty of an unskilled workman and one more unskilled workman was also affected by severe burning who is receiving utmost medical care and treatment at an appropriate hospital in Nagpur-about 50 Km away from the plant.
- (e) The deceased worker family was assured of reasonable compensation and a settlement was accordingly arrived at with the surviving family members of the deceased.
- (f) Due intimation to the Factory Inspector and the Insurance company have been given. Accordingly, the Factory Inspector has already arrived at the plant and the Insurance surveyor will be reaching at the plant on 01-05-2018.

- (g) The company, after completion of survey by insurance surveyor, will be in a position to assess the damage and the period required to re-commence the production in the unit. However, since the fire is localized at Fluid bed dryer equipment only, prima facie understanding is that the Bag House associated with the fluid bed Dryer must have been affected which will require repair including change of bags.
- (h) Considering that the F&D Section will require thorough cleaning and the repair of the said bag house, the expected duration for such activity is estimated at around one week barring unforeseen circumstance.
