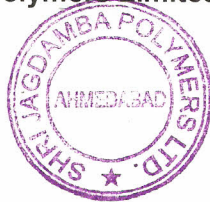

JLR takes centre stage at Harry, Meghan wedding

TATA MOTORS-OWNED Jaguar Land Rover took centre-stage as newly-wed Prince Harry and Meghan Markle, the Duke and Duchess of Sussex, headed to their wedding reception in Windsor.

A silver-blue classic 1960s Jaguar E-Type, remodelled into Jaguar Land Rover's (JLR) electric-powered Jaguar E-Type Concept Zero, was waiting for Harry last evening to drive his new wife to Frogmore House for an intimate wedding reception for 200 friends and family being hosted by his father Prince Charles.

The car bore a special registration number in honour of the royal wedding - E190518 - marking the date of their wedding. With the tag line of "the most beautiful electric car in the world", the vehicle symbolised the couple's eco-friendly side. "Our aim with Concept Zero is to give Classic Jaguars a sustainable future in changing environmental and economic conditions," said Tim Hannig, director of Jaguar Land Rover Classic.

As she stepped out hand-in-hand with Harry in a formal suit, Markle had changed into a white Stella McCartney halter-neck silk crepe gown and Aquazzura shoes with baby blue soles for the black-tie reception. In a break from tradition, she gave a speech at the event to thank her father-in-law the Prince of Wales for stepping into the role of walk-



ing her down the aisle at St George's Chapel in Windsor Castle earlier in the day after her own father Thomas Markle was a no-show due to health reasons.

The 36-year-old former actress also wore a special wedding gift from her new husband in memory of his mother Princess Diana - an emerald-cut aquamarine ring which belonged to the late Diana, Princess of Wales.

Bollywood star Priyanka Chopra, one of Markle's close friends invited to the wedding, took to social media to post a special tribute to the new bride and congratulate the newlyweds. In an emotional Instagram post alongside a series of images of the new couple, she wrote, "Every once in a while there is a moment when time stands still... That happened today... You, my friend, were the epitome of grace, love and beauty. Every choice made at this wedding by you both will

go down in history, not just because it was your wedding but because this incredible wedding stood for change and hope. Both things that the world needs desperately. Thank you for being the perfect picture of all things good," she wrote.

The 33-year-old actress, now famous in Hollywood for her role as Agent Alex Parish in 'Quantico', changed her lavender Vivian Westwood suit from earlier in the day to a golden Dior gown for the evening reception. After performing some of his classics at the lunch reception hosted by Queen Elizabeth II at St George's Hall in Windsor Castle soon after the wedding ceremony at the chapel, pop star Elton John paid tribute to the couple on Twitter, quoting the poet Maya Angelou: "Love recognises no barriers. It jumps hurdles, leaps fences, penetrates walls to arrive at its destination, full of hope."

Meghan promises more time for Indian charity

NEWLY-WED MEGHAN MARKLE, Duchess of Sussex, has promised to give more time to the Indian charity handpicked for donations in lieu of gifts for her royal wedding to Prince Harry, Duke of Sussex.

As the 36-year-old former actress mingled with the 600 guests invited to St George's Chapel in Windsor Castle yesterday, she told Mumbai-based Myna Mahila Foundation founder that she was looking forward to giving more time to the women's empowerment charity. "It was the highlight of the day, to meet the bride. She was as down to earth and as approachable as ever. She said that now she would be able to give more time to Myna and other humanitarian work," said Suhani Jalota, who founded the charity nearly three years ago.

As a guest in the chapel and the lunchtime reception hosted by Queen Elizabeth II soon after at St George's Hall in the Castle, Jalota received lot of compliments for her pastel sari with Indian motifs. Bollywood star Priyanka Chopra, who was among the guests as one of the bride's close friends



from the acting world, also bonded with her over her "very pretty" outfit and their mutual admiration for their mothers' support in their lives.

"It was just such a heart-warming experience... going to the chapel and reception afterwards made the whole thing a lot more grounded. When you perceive this from the outside, it is all about this really glamorous royal wedding but when you are actually there, you see that it's just about love and marriage and friendship and family," said Jalota, who then joined her colleagues on the grounds of the castle.

Deborah Das and Archana Ambre, who had made their first ever plane journey for the royal wedding, described their day as a "once in a lifetime" op-

portunity as they shared ice-creams along with over 2,600 guests invited into the castle on the day.

The group is now set for a special fundraising event titled "Chaat for Change" at Calcutta Canteen in London on Monday evening, when Das and Ambre will be cooking up some Mumbai street food such as bhel puri and pau bhaji to raise funds for the charity.

"It promises to be a great Indian evening. The paus have flown in all the way from a bakery in Thane and we will have some Myna merchandise on sale as well as some Bollywood dancing," said Imogen Mansfield, who completed the foursome representing Myna Mahila Foundation from India for the royal event.

US sanctions on Iran threaten vital Afghanistan trade project

US PRESIDENT DONALD TRUMP's decision to pull out of the Iran nuclear accord and reimpose sanctions on Tehran threatens to derail a project to help build Afghanistan's economy, endangering a key goal of the US strategy to end America's longest war.

The Indian-backed Chabahar port complex in Iran is being developed as part of a new transportation corridor for land-locked Afghanistan that could potentially open the way for millions of dollars in trade and cut its dependence on Pakistan, its sometimes-hostile neighbour.

Building Afghanistan's economy would also slash Kabul's dependence on foreign aid and put a major dent in the illicit opium trade, the Taliban's main revenue source.

But Trump's decision to reimpose sanctions on Iran and penalize financial institutions for doing business with Tehran is clouding Chabahar's viability as banks, nervous they could be

hit with crippling penalties, pull back from financing. "President Trump's decision has brought us back to the drawing board and we will have to renegotiate terms and conditions on using Chabahar," a senior Indian diplomat said. "It is a route that can change the way India-Iran-Afghanistan do business, but for now everything is in a state of uncertainty." The White House did not respond to requests for comment.

Launched in 2016, the joint Iran-India-Afghanistan Chaba-

har project already was facing holdups. It has yet to see significant traffic apart from some containers of donated wheat from India, and the first shipments of Afghan dried fruit to India are not expected before July. At least three contracts to build infrastructure at the port now have been delayed, with two Chinese companies and a Finnish group left hanging while bankers seek clarity from Washington before approving guarantees, a person close to the project said.
