New Delhi, May 18, 2018: The Board of Directors of JTEKT India Ltd (Formerly Known as Sona Koyo Steering Systems Ltd.), India's largest manufacturer and supplier of Steering Systems, in its meeting held on 18th May, 2018 has taken on record the audited Financial Results for the year ended 31st March 2018.

Standalone

For the year ended 31st March 2018, Net Revenue has increased by 4.09% to Rs. 1212.25 Crores as compared to Rs. 1164.60 Crores of the corresponding year. Profit after Tax increased by 32.44% to Rs. 30.80 Crores against Profit of Rs. 23.26 Crores of the corresponding year. The Board has recommended a final dividend @ 50% i.e. Rs.0.50 per equity share of Rs. 1.00 each for the financial year 2017- 18.

Consolidated

For the year ended 31st March 2018, Net Revenue has increased by 3.56% to Rs. 1254.52 Crores as compared to Rs. 1211.44 Crores of the corresponding year. Profit after Tax increased by 32.89% to Rs. 46.69 Crores against Profit of Rs. 35.13 Crores of the corresponding year.
