PRESS STATEMENT:

Ahmedabad, May 02, 2018: 'The Hon'ble Supreme Court has set aside the direction in the order dated 8.1.2016 passed by National Green Tribunal (NGT) against Adani Hazira Port Pvt. Ltd. (AHPPL) cancelling the Environmental Clearance dated 3.5.2013, thereby the Environmental Clearance dated 3.5.2013 granted by MoEF to AHPPL stands restored. The Court has also ordered the return of Rs.25 Cr to AHPPL which was deposited with the Collector, Surat with interest accrued thereon. In the Appeal it was contended that NGT failed to appreciate the facts and no reasons were given which supported the order. NGT ignored the clearances granted by the statutory authorities and observed that the company damaged mangrove whereas a District Inspector of Land Records (DILR) report clearly shows that the mangrove plantation has been carried out.
