The Notice of the EGM, alongwith the Explanatory Statement under Section 102 of the Companies Act, 2013 (the "Act"), the Attendance Slip, Proxy Form & Ballot Form, have been sent through permitted mode to all the Members, whose name appeared in the Register of Members/ List of Beneficial Owners as received from National Securities Depository Limited (NSDL)/ Central Depository Services (India) Limited (CDSL) as on Friday, May 04, 2018. The dispatch of Notices by permitted mode has been completed on May 11, 2018. The Notice of the EGM is also available on the Company's website, www.gkb.net, on the website of the agency, CDSL www.evotingindia.com and also on website of BSE: www.bseindia.com. Members who do not receive the Notice, may download it from the Company's website or may request for a copy of the same by writing to the Company Secretary at gkbophthalmics@gkb.net, Registered Office of the Company. Pursuant to Section 108 of the Act, read with Rules made thereunder and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide its members the facility to cast their vote by electronic means, on all the resolutions set forth in the Notice of the EGM. The details pursuant to the provisions of the Companies Act, 2013 and the Rules are given hereunder:

(i) The business may be transacted through voting by electronic means.
(ii) The remote e-voting period starts on Friday, June 01, 2018, at 08:00 A.M. and ends on Sunday, June 03, 2018, at 5:00 P.M.

(iii) Remote e-voting shall not be allowed beyond 5:00 P.M., Sunday, June 03, 2018.

(iv) Members of the Company holding shares either in physical form or in dematerialized form, as on the cut-off date of Monday, May 28, 2018, only shall be entitled to avail the facility of remote e-voting as well as voting at the EGM. A member may participate in the EGM even after exercising his right to vote through remote e-voting but shall not be allowed to vote again in the meeting.

(v) Any person who acquires shares of the Company and becomes a member of the company after the dispatch of the EGM Notice and holds shares as on the cut-off date i.e. May 28, 2018, should follow the instructions for e-voting as mentioned in the EGM Notice for FIRST TIME USER, which is available on the Company's website. In case of any queries, the member may also contact the Registrar & Transfer Agent viz. M/s. Sharex Dynamic (India) Pvt. Ltd. and obtain necessary login-id and password.

(vi) The facility of voting through Polling Paper shall be made available at the EGM and the members attending the meeting who have not cast their vote by remote e-voting shall be able to exercise their right at the meeting through Polling Paper.
