The ruling AAP accused the central dispensation of keeping the party ministers and MLAs in controversy to ensure that the work done by the Delhi government was not highlighted among the people.

It said the 'raid' was an attempt to divert people's attention from the "good works" done by the Arvind Kejriwal government.

"Our MLAs have been acquitted by courts in all cases registered against them," Khetan told reporters here.

The AAP leader also alleged that the CBI and Delhi Police have been trying to "implicate" AAP leaders in false cases.

"Raid is conducted on us so that an elected government is not allowed to work. In the history of democracy in 70 years, such harassment of an elected government has never been done by central agencies," Khetan said.

Talking to reporters, AAP leader Raghav Chaddha said Prime Minister Narendra Modi and BJP chief Amit Shah have been unable to "digest" the huge mandate received by the AAP in the 2015 Delhi Assembly elections.

"Since the AAP got 67 out of 70 seats in Delhi, Modi and BJP chief Amit Shah have not been able to digest their defeat. No agency is left under the NDA-led Centre which has not attacked the AAP government," he said.

"Be it CBI, ED, Economic Offences Wing and the Delhi Police, they (Centre) have tried to threaten us (AAP)," Chaddha said.

Multi-level parking charges to be one-third of surface parking rates: **PMAP** New Delhi

Civic bodies in Delhi will levy one-third charges for multi-level parking facilities compared to surface parking rates, according to the parking management area plan (PMAP) for the national capital being firmed up by the Delhi government that seeks to decongest the city and also make it pedestrian-friendly.

"The idea is to come up with a holistic parking policy for the city, which also addresses needs of pedestrians. We also want to discourage long-term surface parking and incentivise multi-level parking to keep the city decongested," Deputy Commissioner, R P Cell, Prem Shankar Jha, said.

"So, in the plan we have proposed that charges for multi-level parking should be one-third of the rates for surface parking," the official said.

#### Blind murder case solved, youth arrested

South East District police on Wednesday solved a blind murder of a-30-year-old youth who was stabbed 14 times near domestic container depot in Okhla industrial four five day ago.

According to the police, the accused has been identified as Sandeep alias Bulli. He was arrested from Okhla Phase 1," said DCP South East Chinmoy Bisw-During the investigation,

police found a bank slip from his pocket with a name Arvind Chauhan who was later identified from Face-Since it had blood stains

on it the cops assumed the motive of the murder was robbery as the attacker would have scanned the pockets of victim.

The team then contacted his kin and the body was sent for post mortem. During further investigation, detailed enquiry from locals was conducted and secret informers were also deployed by investigators.

Technical surveillance was mounted. During technical surveillance, the mobile phone of the deceased was traced from the possession one man which led to a chain findings where ultimately our team was led to one Sandeep alias Bulli.

The interrogation of Sandeep revealed some startling fact. He disclosed that he is an alcoholic and used to work in Punjab as painter and came to Delhi 4 days ago. He was living with his brother in Okhla. On the night of incident that is 26 May at around 10 pm he had craving for beer and had no money to meet his needs. He went to a nearby meat shop and stole a butcher knife from there. After that he went towards Container Depot and looked

However, when he tried to rob Arvind, he resisted forcefully and caught hold of the attacker's hair. Sandeep then panicked and stabbed Arvind 14 times killing him on the spot.

#### Delhi govt comes out with timeline for e-buses procurement

**New Delhi** 

Undeterred by the Supreme Court-appointed EPCA's objection to procurement of ebuses using green fund, the Delhi government has set a target of rolling out 1,000 ebuses next year.

According to the Delhi government's "outcome budget" under which different departments set target for executing their schemes and projects, supply of ebuses by the manufacturers to concessionaire will begin from March 31, 2019 onwards.

The timeline for the project stipulates appointment of a consultant by June 1.

Earlier this month, the Supreme Court had directed the Environment Pollution Control Authority (EPCA) to examine the Delhi government's proposal to procure the e-buses by using a part of Rs 999.25 crore environment compensation charge (ECC) fund.

## दाय सेना के त्रांन विद्यार्थियों ने की आत्महत्या

कंद्रीय माध्यमिक शिक्षा बोर्ड (सीबीएसई) द्वारा संचालित 10वीं कक्षा की परीक्षा में अच्छा अंक नहीं ला पाने से परेशान राजधानी के तीन विद्यार्थियों ने कथित तौर पर फांसी लगाकर आत्महत्या कर ली। पुलिस ने कहा कि मृतकों में से एक की पहचान रोहित कुमार मीणा (17) के रूप में की गई है। वह द्वारका के एम आर. विवेकानंद मॉडल स्कूल का छात्र था। ककरोला निवासी मीणा ने परीक्षा में 59 फीसदी अंक हासिल करने के बार अपने कमरे में आत्महत्या कर ली। उसे एक स्थानीय अस्पताल में ले जाय गया, जहां उसे मृत घोषित कर दिया गया। पुलिस के अनुसार, इस घटना के बारे में अपरान्ह करीव 3.45 बजे एक कॉल आई थी। मामले में कोई सुसाइड नोट नहीं मिला है, लेकिन पुलिस को संदेह है कि वह परीक्षा परिणाम को लेकर परेशान था।

एक वरिष्ठ पुलिस अधिकारी ने कहा कि दूसरे मामले में दक्षिणी दिल्ली के वसंत कुंज इलाके में रहने वाली छात्रा प्रज्ञा पांडेय (15) का शव अपने घर में पंखे से लटका हुआ मिला। प्रज्ञा रयान स्कूल की छात्रा थी और उसने 70 फीसदी अंक हासिल किए थे। वह साइंस पढ़ना चाहती थी, लेकिन 'कम फीसदी' को चजह से ऐसा नहीं कर सकती थी। उन्होंने कहा कि उसके पित्र प्रवर्तन निदेशालय (इंडी) में प्रवर्तन अधिकारी हैं। एक पुलिस अधिकारी ने कहा कि छात्रा खुशबू (17) ने डाबरी इलाके में जान दे दी। वह दो विषयों में अनुत्तीर्ण हो गई थी।
