
This is to inform that the Board of Directors of the Company at its Meeting held today i.e. 23rd May, 2018 has inter alia, considered and:

1. We have audited the accompanying Statement of Consolidated financial results of Vindhya Telelinks Limited ("the Parent Company") and its subsidiaries ("the Parent Company and its subsidiaries referred to as "Group"), a jointly controlled entity and its share of the profit in associates for the year ended 31st March 2018, ("The Statement"), being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as modified by Circular no. CIR/CFD/FAC/62/2016 dated July 5, 2016. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared on the basis of related financial statements which are in accordance which are in accordance with the Indian Accounting Standards ('Ind AS') specified under Section 133 of the Companies Act, 2013, as applicable, and other accounting principles generally accepted in India. Our responsibility is to express an opinion on the statement.
2. We conducted our audit in accordance with the Standards on Auditing issued by the Institute of Chartered Accountants of India. Those standards require that we plan and perform the audit to obtain reasonable assurance about whether the Statement is free of material misstatement. An audit includes examining, on a test basis, evidence supporting the amounts disclosed in the Statement. An audit also includes evaluating the appropriateness of the accounting policies used and the reasonableness of the significant accounting estimates made by Management, as well as evaluating the overall presentation of the Statement. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.
3. a) The Accompanying consolidated Ind AS financial results include the Ind AS financial statements of 3 subsidiaries, whose Ind AS financial statements reflect total assets of Rs. 21,121.48 lacs as at March 31, 2018, total revenues of Rs. 2,097.87 lacs and net cash outflows amounting to Rs. (2.90 lacs) for the year ended on that date, as considered in the accompanying consolidated Ind AS financial results. These financial statements have been prepared in accordance with accounting principles generally accepted in India including the Accounting Standards specified under section 133 of the Act, read with Rule 7 of the Companies (Accounts) rules, 2014 have been audited by other auditors. The Parent's management has converted the Audited financial statements of 3 subsidiaries from Accounting Standards specified under section 133 of the Act, read with Rule 7 of the Companies (Accounts) rules, 2014 to Indian Accounting Standards (Ind AS) prescribed under Section 133 of the Act. We have audited these conversion adjustments made by the Parent's management. Our opinion in so far as it relates to the amounts and disclosures included in respect of said 3 subsidiaries is based on the report of other auditors and the conversion adjustments prepared by the management of the Parent and audited by us.



b) The consolidated Ind AS financial statements also include the Group's share of net profit (including OCI) of Rs. 291.87 lacs and Rs. 7,617.80 lacs for the year ended March 31, 2018 and March, 2017 and share of net assets of Rs. 14,181.80 as at 1st April, 2016, as considered in the consolidated Ind AS financial statements, in respect of an Associate, whose financial statements have not been audited by us. These Ind AS financial statements are unaudited and have been furnished to us by the Management and our opinion on the consolidated Ind AS financial statements, in so far as it relates to the amounts and disclosures included in respect of the associate, is based solely on such unaudited financial statements.

c) The comparative financial statements for the year ended March 31, 2017 in respect of an Associate included in this Accompanying consolidated Ind AS financial results prepared in accordance with the Ind AS have been audited by other auditors and have been relied upon by us.

Our opinion on the statement is not modified in respect of the above matters with regard to our reliance on the work done and the reports of the other auditors.
