

Interestingly, the Congress will be citing the recent example of Karnataka to make a rejuvenated effort to destabilise the existing BJP coalition. That Chief Minister Manohar Parrikar is undergoing treatment in the US has added to the discomfort of the BJP. The Congress on Thursday rushed its senior leaders and AICC Secretary Dr A Chella Kumar, in-charge of Goa affairs, to Panjim. They will meet Governor Mridula Sinha on Friday to assert that the Congress is the single largest party even now and hence she should follow the example of Karnataka to let it form the government, party sources said. In Manipur, former chief minister Okram Ibobi Singh has also staked claim to forming the government and will meet the governor.

Meanwhile, the Congress is preparing a similar strategy for Meghalaya where, in the recently held Assembly polls, it won the maximum seats: 21 in the 60-member Assembly.

Asnani Builders evaded ...

The group had bought these lands in the names of their relatives and other persons. It is being investigated as to whether these persons, on whose names these lands were bought, had capacity to buy them. A case under 'Benami property' may be lodged against the group. Joint ventures in the name of family have been made, through which properties were bought. The sources in I-T department said there is possibility of the group committing tax evasion to the tune of around Rs 100 crore. So far, Rs 50 lakh in cash and jewellery to the tune of Rs 1 crore have been seized from the establishments of people linked to the group. The I-T sleuths have also found more than a dozen bank lockers. The sources in I-T department said it has come to fore that politicians, bureaucrats and businessmen had invested in the group. These people made land deals with the group and also invested money in their business. Sources said these people will be issued notices after completion of investigations.

19-yr-old gets death for raping ...

Next morning, when few village women went to attend nature's call on the bank of the river flowing near their village, they saw the child's body. They immediately called police and victim's parents. During preliminary investigation, victim's elder sister informed police that she saw her sister playing with Karan near their house. Police without wasting time arrested Karan and interrogated him. During police interrogation, Karan confessed to his crime. Police produce charge sheet in the matter within 19 days along with DNA report. Manawar MLA Ranjana Baghel expressing satisfaction over the court's judgment said that death penalty is the only option left for such heinous criminals in the country. It will create panic among the accused and will automatically reduce such crime. Similarly, Manawar municipal council president Sangeeta Shivram Patidar said that there is no right for such criminals to live in the society. We treat girl children as goddesses and those who rape and murder them deserve only the death penalty.
