Fisherman in Pak jail suffering from cancer, wife seeks Swaraj's help

A WOMAN from Gir-Somnath. the wife of a fisherman, on Tuesday wrote a letter to External Affairs Minister Sushma Swaraj, seeking help in bringing her husband, who is in a Pakistani prison, back to India on the account that he is suffering from cancer.

Rudiben Chauhan (32), resident of Paldi in Una tehsil, said that her husband Danabhai Chauhan (35) was imprisoned over a year ago. According to her, Chauhan and five other fishermen from Gujarar were apprehended by the Pakistan Maritime Security Agency near the Jakhau port in Kutch district on May 3. 2017, for allegedly entering the Pakistani waters. Their boat. "Sagar Sonu", was also seized.

Rudiben Chauhan said that her husband allegedly called his nephew from a hospital in Pakistan three days ago, and said that he was suffering from cancer and he must return to India for better treatment, "My husband said he does not want to die in Pakisrani iail." she said.

The couple has four daugh-

ters and a son, In her letter to Swarai, Rudiben has said it is the responsibility of Pakistani jail authorities to inform the prisoner's family about his disease, but they failed to do so. She said that she has not even received any communication from the Ministry of External Affairs or the Indian High Commission about her husband's condition. "I seek your help for doing the needful," Chauhan wrote to Swarai.

Since her husband's caprured, Rudiben has been working as a labourer to feed her four children, the eldest of whom is 12-year-old and the youngest is one-and-a-half year old. "I earn Rs 100 a day which is not enough to feed my children," she wrote in the letter.

Raiya Sabha member Parimal Nathwani, who hails from Gir Somnath district, and Velijbhai Masani, vice president of the Gujarat Fishermen's Association (GFA), said that they have also written separate letters to the External Affairs Minister, requesting her to bring back Chauhan. According to the GFA, presently 415 Indian fishermen are languishing in Pakistani jails for allegedly crossing the international maritime border illegally.
