Sub: Disclosure pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 by SEL Manufacturing Company Limited ("Company")

Reference is drawn to the disclosure made to the stock exchanges on May 24, 2018 in respect of *inter alia* the insolvency commencement date, the appointment of the interim resolution professional and the period during which the interim resolution professional was required not to take over management of the Company on account of the court orders, as detailed in the said disclosure.

As per the listing requirements, the Company needs to publish its audited financials/results for the Financial year 2017-18 by May 30, 2018. On account of the interim resolution professional of the Company ("IRP") being in the process of taking over *inter alia* (a) the management of the affairs of the Company and (b) the custody and control of the Company's assets, from May 23, 2018 after the expiry of the period in which it was restricted to do so by the court orders, as listed in the disclosure made on May 24, 2018 and the extremely limited time left for the expiry of the 60 days time period provided under Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, it would not be possible to consider and take on record the audited results on standalone basis and

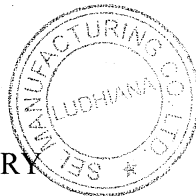
