We had in our earlier communications Informed that Corporate Insolvency Resolution Process (CIRP) has been initiated for Orissa Minerals Development Co.Ltd. (The Company) under the provisions of the Insolvency and Bankruptcy Code, 2016 ('Code') vide an order of the Honourable National Company Law Tribunal with effect from 20th February 2018.
