# Sub: Update on Disqualification of Directors under Section 164(2) of Companies Act, 2013 Ref: Our Letter dated 8<sup>th</sup> March, 2018

In continuation of our disclosure made to the stock exchange on 8<sup>th</sup> March, 2018, we would like to inform the following facts:

- 1. The Company had received letters dated 23<sup>rd</sup> April, 2018 from Mr. Tarique Ansari and Mr. Adille Sumariwala respectively (*Copies of the said letters are enclosed herewith*).
- 2. Vide the aforesaid letters, they have provided the Company with the following facts:
  - (a) Bombay Marathon Private Limited has filed all the overdue documents under the Condonation of Delay Scheme, 2018 and has also filed Form e-CODS with the Registrar of Companies by paying required fees of INR 30,000 and the said Form is approved. (*They have submitted to the Company, the copies of all the filings done by the M/s. Bombay Marathon Private Limited and the Form e-CODS filed with the Registrar of Companies*)
  - (b) The status of their DINs is now shown as 'Approved' on MCA portal.
  - (c) Since Bombay Marathon Private Limited has rectified the default and the status of their DINs is approved, their disqualification has also been removed and they can resume the office of Directors and act as Directors of the Company
- 3. Meanwhile, the Company had also sought the opinion of a Practising Company Secretary on this issue.
- 4. The Board of Directors of the Company have, at their meeting held on 8<sup>th</sup> May, 2018 considered the letters received from the above mentioned directors and also the opinion received from Practising Company Secretary. After considering the same, the Board have taken the view that the disqualification incurred by the aforesaid directors has been removed and hence, they can now resume the office of directorship in the Company. Accordingly, Mr. Tarique Ansari and Mr. Adille Sumariwala have resumed the office of Chairman & Managing Director and Independent Director respectively.
- 5. Further, the Board of Directors have decided to monitor and review any clarification/regulatory update that may be issued by the Ministry of Corporate Affairs in this regard so that if needed by the said clarification/regulatory update, the Board may take steps as required.
