Nestlé India commitment towards plastic waste management

As a responsible business and the world's largest food and beverage company, Nestlé India has always been committed to environmentally sustainable business practices at all stages of production making the right choices to protect the future. Our initiatives are spread across the entire value chain and we engage with farmers, suppliers, employees and consumers to help increase awareness about environment sustainability. We are consistently minimising consumption of natural resources and reducing water, energy and specific direct gas emissions while maximising production volumes.

Reiterating Nestlé India's commitment towards environmental sustainability, **Mr. Sanjay Khajuria, Senior Vice President - Corporate Affairs, Nestlé India**, said, "We are committed to finding improved solutions to reduce, recycle and recover that paves the way for a healthier environment. To achieve this goal we have collaborated with various stakeholders across, NGOs, academia, state governments and waste aggregators. We have reduced our packaging materials significantly over the last few years through packaging optimisation and will continue to work in this direction."

We are committed to the 3R's principle:

- **REDUCE:** In 2017, the Company reduced packaging material weight by approximately 1,532 tonnes by ensuring eco designing of packaging in a sustainable way
- **RECYCLE:** Encourage the use of recycled material wherever possible that can benefit the environmental
- **RECOVER:** Support initiatives to recycle or recover energy from used plastic

As a responsible company, we have initiated projects on waste management by engaging with relevant stakeholders:

- Installed the Gasolyser at Nestlé's Tahliwal factory in Himachal Pradesh that converts plastic waste into fuel.
- Collaborated with industry bodies and organisations like Indian Pollution Control Association (IPCA), NEPRA and Saahas Waste Management to conduct education and awareness programme, workshops, street plays for waste pickers, waste dealers, traders and aggregators communities. Created a network of approximately 1000 waste pickers in eight cities.
- Initiated the second phase of Extended Producer Responsibility (EPR) in partnership with other stakeholders to manage plastic waste in 12 states.
- Partnered with Saahas Waste Management and NEPRA towards collecting, segregating and disposing waste in states of South India and Gujarat. We will be approximately investing INR 40 million as we rollout this program.
