MV SSL Kolkata, a vessel of Shreyas Shipping & Logistics, on June 13 met with an accident - an explosion followed by fire on its deck/holds. The ship's crew is safe, the company said in a notice to the stock exchanges. The incident had happened when the ship was travelling from Krishnapattinam to Kolkata at around 22.15 hours.
