Note - Ruchi Infrastructure Limited and Evershine Oleochem Limited have sold 15,00,000 and 25,00,000 equity shares respectively and have made due disclosure in terms of Regulation 7 (2) of SEBI (Prohibition of Insider Trading)
Regulations, 2015, however, the effect of such sales has not been reflected in above details. Post such sale, Ruchi Infrastructure Limited holds 67,59,625 equity shares ( out of which 65,00,000 equity shares are pledged) and Evershine
Oleochem Limited does not hold any equity shares in the Target Company.
