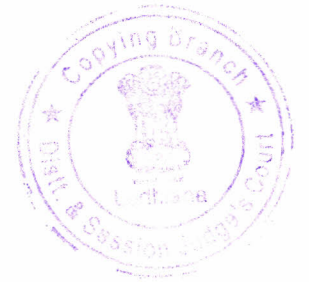

Present: Sh. Stevon Soni, Advocate, for plaintiff

File put. up before me being Vacation Judge. Sh. Sajan Kumar, Advocate, appeared on behalf of Caveator and has requested that Senior Counsel Sh. Shiv Sharma, Advocate, has gone abroad and he would be available in July only. The matter is with regard to Initial Public Offer of Rs.550 crores to be launched by respondents by using the name 'Monte Carlo' whereas applicants alleged that they have a well recognized trade mark a 'Monte Carlo' and in case Public Issue is opened it would lead to lot of confusion. At this Court requested Sh. Sajan Kumar, Advocate, to come out with the date of opening of Initial Public Offer but Sh. Sajan Kumar, Advocate, is unable to assist the Court even with the date of opening of public issue. In such circumstances, in case public issue is opened in the absence of Sh. Shiv Sharma, Advocate, from India, the relief claimed by applicants would become infructuous. So respondents are restrained from issuing the Initial Public Offer till 9.7.2018, by using name 'Monte Carlo' the date is fixed at the request of Sh. Sajan Kumar, Advocate. File be put up before learned District Judge, Ludhiana, 2.7.2018 for entrustment.
