 27th Annual General Meeting of the Members of the Company is scheduled to be held on <u>Wednesday</u>, <u>25 July 2018 at 12 noon</u> at 'Pudumjee Hall', Mahratta Chamber of Commerce, Industries and Agriculture, Tilak Road, Near Nehru Stadium, Swargate Corner, Pune 411002.

2. Regulation 42 of the SEBI LODR Regulations

The Register of Members and the Share Transfer Books of the Company will remain closed from Monday, 16 July 2018 to Wednesday, 25 July 2018 (both days inclusive) for the purpose of declaration of dividend at the Annual General Meeting.

3. The Board of Directors at its meeting held on 3 May 2018 has recommended the Dividend of Rs. 1.25 per equity share of Rs. 5 each (i.e. 25 percent) for the financial year 2017–2018, for the approval of the Members at the Annual General Meeting.

4. Regulation 12 of the SEBI LODR Regulations

The Dividend, if declared by the Members at the Annual General Meeting, will be paid on or before 1 August 2018 by way of various modes of payment such as Direct Credit, NEFT, RTGS, NECS / ECS, Dividend Warrants or Demand Drafts, as the case may be, to those Members:

- a) whose names appear as Beneficial Owners as at the end of the business hours on 15 July 2018 in the list of Beneficial Owners to be furnished by the National Securities Depository Limited and the Central Depository Services (India) Limited in respect of equity shares held in electronic form and
- b) whose names appear as the Members in the Register of Members of the Company after giving effect to valid share transfers / transmissions in physical form lodged with the Company or its Registrar and Share Transfer Agent on or before 15 July 2018.
