As per the Scheme, the record date is required to be fixed in consultation of the Board of Directors of MIPL.

However, the Registrar of Companies, Mumbai has marked MIPL as a "Company having Management dispute" and therefore, the Board has decided to immediately approach to Hon'ble Bombay High Court and/or to Hon'ble NCLT, Mumbai requesting that in view of the hearing already scheduled in NCLT on 26th June'2018 in this matter, an Administrator may be immediately appointed by the Hon'ble Tribunal on the board of MIPL to exercise all the powers of the Board of Directors of MIPL in respect of Record date consultation, issue, allotment and listing of the shares to be issued by MIPL in pursuance of the scheme of arrangement sanctioned by Hon'ble Bombay High Court.

In the said meeting, the Board, in order to achieve the objective of improving the liquidity and to further deleveraging the Company, has also decided to disinvest/sale its shares/stake held in its wholly owned subsidiary Merino Shelters Pvt. Ltd, as per the fair valuation to be carried out by any of the prominent investment bankers/ consultants/ advisors/ valuation agencies, to be appointed in this regard through a Committee of directors, comprising of Independent Director. subject to the approval of the same by the shareholders in the ensuing AGM.
