किसान आंदोलन एक जून से

चंडीगढ़, चार्ना। देश भर के 172 किसान इकाइयों के आह्वान पर पंजाब तथा हरियाणा के किसान एक जून से दस दिनों तक न शहरों में आयेंगे और न ही बाजार में दूध तथा सब्जी की सप्लाय करेंगे। पड़ोसी राज्यों की किसान युनियनों के प्रतिनिधियों ने आज एक बैठक करके सभी किसानों से अपील की है कि सरकारों इनकी भांगों के प्रति संवेदनशील नहीं हैं और यही कारण है कि उनकी लंबे समय से जारी भांगों पर कोई गौर नहीं किया गया। किसानों की उपेक्षा की जा रही है।

दिल्ली जिले में किसानों की बैठक को संबोधित करते हुए संदीप शेरपुरा ने बताया कि किसान दस दिन तक शहरों में अपना उत्पादन लेकर आये तथा अपने गांव में ही दूध सब्जी बेचनी होगी। यदि कोई नागरिक शहर से आकर दूध सब्जी खरीदना चाहता है तो उसे सब्जी या दूध अपने व्यक्तिगत टायर पर बेच सकता है। उन्होंने कहा कि दस जून तक शहर से कोई भी खरसू नहीं खरीदनी है और न ही बेचनी है। गांव के लोग गांव में ही एक दूसरे से लेन देन करें। किसान नेता सुरेश दाका ने बताया की यह मुहिम देशभर में 1 जून से 10 जून तक चलेगी इस मुहिम में 172 किसान संगठन शामिल हैं। इस आंदोलन की तीन मुख्य भांगों में स्वामीनाथन आयोग रिपोर्ट लागू करना।

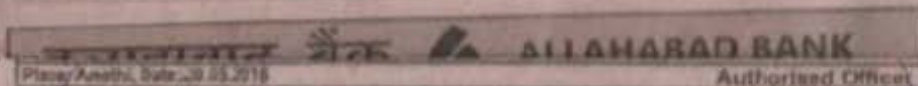
