સેબીએ એડસર્વ સોફ્ટસિસ્ટમ્સના આઈપીઓમાં બે જણાને દંડ કર્યો

પીટીઆઈ નવી દિલ્હી, તા. ૩૦ બજાર નિયમનકાર સિક્યુરિટીઝ એન્ડ એક્સચેન્જ બોર્ડ ઓફ ઈન્ડિયા (સેબી)એ એડસર્વ સોફ્ટસિસ્ટમ્સને કિંબા એન્ટરપ્રાઈઝીસ અને રાજેશ સર્વિસિસ સેન્ટર દ્વારા તેમના પ્રારંભિક જાહેર ભરણા (આઈપીઓ) મારફતે છેતરપિંડીપૂર્વક ભંડોળ એકત્રિત કરવામાં મદદરૂપ બનવા બદલ રૂ ૧.૧૦ લાખનો દંડ કર્યો હતો. સેબીએ એનએસઈ પર એડસર્વના જાહેર ભરણાની તપાસ કરવા ૨-૯, માર્ચ, ૨૦૦૯થી અને બીએસઈ ખાતે માર્ચ, ૨-૬, ૨૦૦૯ દરમિયાન તપાસ હાથ ધરી હતી. તપાસ દરમિયાન એડસર્વ પાસેથી રૂ. ૪.૭૫ કરોડ મેળવવામાં આવ્યા હતા અને

કિંબા એન્ટરપ્રાઈઝીસ-કે રાજેન્દ્રનનો આ કેટલીક એન્ટીટીઝમાં સમાવેશ થતો હતો- અને રાજેશ સર્વિસિસ સેન્ટર- આર ધનાલક્ષ્મી તેના મુખ્ય પ્રોપ્રાઈટર હતા, જે ભંડોળને ખસેડવાને લઈ મદદરૂપ બનેલા. એક આદેશમાં સેબીએ જણાવ્યું હતું એડસર્વ પાસેથી મળેલા રૂ ૧.૩.૭૫ કરોડ પૈકી કિંબા એન્ટરપ્રાઈઝીસ અને રાજેશ સર્વિસિસ સેન્ટરે અનુક્રમે રૂ ૧.૧.૫ કરોડ અને રૂ. ૨.૨૫ કરોડ મેળવ્યા હતા. અલબત્ત મહાદેવ ઈમ્પેક્સ, શિવ ઈન્પેક્સીસ, એસ કે એલોઈસ એન્ડ ટ્રેડિંગ અને રેમકો ઈન્ટરનેશનલમાં આ સમગ્ર રકમને સમાન દિવસે અથવા ત્યારપછીના દિવસે ટ્રાન્સફર કરવામાં આવી હતી.

મ્યુચ્યુઅલ ફંડોએ આઈટી ક્ષેત્રમાં એપ્રિલમાં સૌથી વધુ રોકાણ કર્યું

પીટીઆઈ નવી દિલ્હી, તા. ૩૦ યુએસ ડોલર સામે રૂપિયાના મૂલ્યમાં ઘટાડો અને બજારમાં ભારે અફરા તફરી વચ્ચે મ્યુચ્યુઅલ ફંડ ઉદ્યોગો તેમના ઈકિવટી રોકાણ તરીકે આઈટી સેક્ટરની કંપનીઓમાં મોટાપાયે રોકાણ ધરાવે છે. મ્યુચ્યુઅલ ફંડોએ આઈટી સેક્ટરના શેરમાં એપ્રિલ મહિના દરમિયાન અત્યાર સુધીનું સૌથી વધારે રૂ. ૭૧,૦૦૦ કરોડનું રોકાણ કર્યું હતું. જાન્યુઆરીથી મ્યુચ્યુઅલ ફંડ હાઉસિસે આ સેક્ટરમાં તેમનું રોકાણ વધાર્યું છે. આઈટી સેક્ટરની કંપનીઓ તેમની

જણાવાયું હતું. તેની તુલનામાં માર્ચ મહિનામાં આ રોકાણ રૂ ૧.૬૪,૨૬૫ કરોડ હતું. વર્તમાન સ્તરે મ્યુચ્યુઅલ ફંડ ઉદ્યોગ ઓગસ્ટ, ૨૦૦૯થી સોફ્ટવેર સેક્ટરમાં અત્યાર સુધીનું સૌથી મોટું રોકાણ ધરાવે છે. અલબત્ત વિવિધ- સેક્ટરમાં રોકાણને લગતી આંકડાકીય માહિતી ઉપલબ્ધ નથી કે જ્યારે સોફ્ટવેર શેરોમાં રૂ ૧.૧૧,૯૧૩ કરોડ (૬.૭૧ ટકા) રોકાણ કરવામાં આવ્યું હતું. આ વર્ષે ઈકિવટી ફંડ મેનેજર્સ દ્વારા સોફ્ટવેર સેક્ટરના શેરોમાં સતત રોકાણમાં વૃદ્ધિ જોવા મળી રહી છે અને રોકાણનું આ પ્રમાણ જાન્યુઆરી
