Recovery hopes of telecom investors pushed to FY20

New packages from Jio indicate the pricing war is set to continue at least in FY19

Investors banking on a recovery in the telecom sector in FY19 will have to wait a bit longer given that the intensity of pricing war just got worse. After introducing attractive post-paid plans to get premium customers from incumbents, Reliance Jio (Jio) launched new plans to maintain its competitive lead. Jio recently doubled its data offerings to 3 gigabytes (GB) per day on plans ranging from ₹149 to ₹449. This is in response to Bharti Airtel's offer increasing its data offerings by 70 per cent for ₹399 pack and doubling data allowance for ₹199 pack for select customers. With lower tariffs, Jio has kept to its strategy of being the most affordable operator, and analysts expect it to respond every time incumbents lower tariffs, thus keeping a pricing The new packs come soon after

Jio offered a 50 per cent cut in tariff for post-paid connections, below prices of incumbents. The move effectively caps prices incumbents could charge their high-margin customers, and thus, denting their profitability. Analysts, hence have cut profit estimates for Airtel and Idea for FY19 and FY20. SBICAP Securities now expects a recovery in average revenue per user (ARPU) only in FY20. "We do not see any significant decrease in competitive intensity in the near-term as Jio remains focused on market share gains, and incumbents continue to struggle with weak cash flow generation and stretched balance-

Jio's strategy of grabbing market share is working. At the end of the sector.



March quarter, Jio's adjusted gross revenue share was 25.6 per cent, just behind Airtel-Tata Tele's 30.2 per cent and Idea-Vodafone's 37.5 per cent. Both Airtel and Idea-Vodafone combine have lost over 1,000 basis points in market share each over the last four quarters. While smaller telcos have been big losers, given Jio's offerings, more market share loss for incumbents cannot be ruled out. Jio is targeting 50 per cent revenue market share

What is compounding matters is industry's shrinking size, with March quarter revenues down 18 per cent year-on-year and 11 per cent sequentially. At ₹243 billion. quarterly industry revenues are at their lowest since 2011. While Idea (given its low ARPU base) remains most vulnerable to market share loss, its merger with Vodafone will be the key trigger. For Airtel, its response to Jio's new tariffs will set

Revival in volumes places Marico in a sweet spot

Management aims for double-digit volume growth; margins may see some pressure

Despite a subdued performance by Marico in the March 2018 guarter (Q4) owing to high copra prices (a key input) and dismal volume growth, the stock is up 8 per cent since May 2, 2018. What's mainly making investors confident is an expected recovery in volumes.

Due to a 5 per cent fall in the flagship product, Parachute, and 1 per cent in Saffola, Marico had posted a meagre one per cent rise domestic volumes in Q4 (overall volume growth in FY18 was 1.3 per cent). However, volumes are likely to ramp up going ahead. "The company aims to deliver double-digit volume growth in the India business in FY19 and in the medium term, through expansion of core portfolio and new products," Marico's management said in an

Even analysts expect improvement in rural demand, volume recovery in coconut oil segment, and goods and services tax implementation to push up Marico's growth numbers. Moreover, volumes of Saffola, which were under pressure, are also likely to improve, albeit slowly, supporting overall

The management, however, also says, "The company continues to focus on protecting and growing our franchise at the cost of short-term profitability."

With input cost pressure (average copra prices up 44 per cent year-on-year in June 2018 quarter (Q1), so far) along with the indication to not fully pass on this presterm margins under pressure.



Analysts, though, see some leeway to protect profitability. "Gross margin will continue to remain under pressure over near term. But, Marico may cut its other operating expenses such as advertising to lower the impact of gross margin compression," says Abneesh Roy. senior VP, institutional equities, Edelweiss Securities.

Notably, copra prices have come down marginally on a sequential basis in the last couple of weeks, providing some relief. Besides, if management's expectation of copra prices softening from October 2018 onward comes true, gross as well as overall margins should improve.

Given the volume recovery and hopes on the margin front, analysts expect Marico's overall performance to improve faster in the second half of FY19. And this should help the Marico stock, which after lagging key indices sure to consumers may keep near- in the past year, has started
