While the existing Prevention of Money Laundering Act (PMLA) has provisions for confiscation of an offender's assets, it's only after his conviction, and the attachment is also limited to the proceeds of crime. In June, the Bengal government had notified its own regulation, Housing & Industrial Regulation Act (HIRA), and notified rules thereunder.

The Ministry of Housing and Urban Affairs has sought the law ministry's view on whether two separate Acts on regulation of the real estate sector — one enacted by the Centre and the other by West

Bengal — can coexist. Both the RERA and the HIRA differ on the definition of the force majeure clause and garage space.
