SUMMARY OF PROCEEDINGS OF THE 4TH ANNUAL GENERAL MEETING

The 4th Annual General Meeting (AGM) of the Members of Pudumjee Paper Products Limited (the Company) was held on Saturday, 21st July, 2018 at 3.00 p.m. at the Registered Office of the Company at Thergaon, Pune - 411033.

Mr. A. K. Jatia, Chairman of the Board, chaired the Meeting. The requisite quorum being present, the Chairman called the Meeting in order. Thereafter, he introduced the Board Members who were present at the Meeting.

Mr. Punit Agrawal of M/s. J. M. Agrawal & Co., Auditors of the Company was present at the meeting.

The Chairman then delivered the speech. The Chairman also provided clarifications/answers to the queries raised by the members.

The Chairman informed that pursuant to Section 108 of the Companies Act, 2013 and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company had provided to the Members the facility to cast their votes electronically in respect of all businesses mentioned in the Notice. The remote e-voting facility was kept open for a period of 3 (three) days i.e. from Wednesday, 18th July, 2018 (9.00 a.m.) to Friday, 20th July, 2018 (5.00 p.m.) Members who had not cast their votes electronically and were present at the Meeting were provided an opportunity to cast their votes at the Meeting through Ballot Papers.

The following items of business as set out in the Notice of AGM dated 26th May, 2018 were transacted / discussed at the Meeting:

- To consider and adopt the Standalone Audited Financial Statements of the Company for the Financial Year ended 31st March, 2018 comprising the Audited Balance Sheet as at 31st March, 2018 and the Statement of Profit and Loss and Cash Flow Statement for the year ended on that date and the Reports of the Board of Directors, Auditors thereon.
- 2. Appointment of a Director in place of Mr. Arunkumar Mahabir Prasad Jatia (DIN: 01104256), who retires by rotation and being eligible, offers himself for reappointment.
- 3. Declaration of a Dividend on equity shares of the Company for the year 2017-18.
- 4. Ratification of appointment of M/s. J. M. Agrawal & Co., Chartered Accountants (Firm Registration No.100130W), the Auditors of the Company and fixing their remuneration.
- 5. Consent to the subsisting contracts already entered/to be entered into with Related Party(ies).
- 6. Consent of Shareholders for acceptance of fixed deposits from Members and from the Public in general.
