In compliance with Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended, we would like to inform you that pursuant to the application made by eligible applicant(s) for allotment of the rights shares out of shares reserved in favour of the CCD holders in accordance with the provisions of Regulation 53 of SEBI (Issue of Capital and Disclosure Requirements) Regulations, 2009 and Letter of Offer dated 1st February, 2018, the Committee of Directors (Rights Issue) has today i.e. July 5, 2018, considered and approved the allotment of 5,269 equity shares of face value of Rs.2 each, at an issue price of Rs. 2,380 per equity share including a premium of Rs. 2,378 per equity share.

Pursuant to the aforesaid allotment:

- 1. The paid up share capital of the Company stands increased from 180,592,514 equity shares of Rs. 2 each amounting to Rs. 361,185,028 to 180,597,783 equity shares of Rs.2 each amounting to Rs. 361,195,566; and
- The reservation portion in favour of CCD holders stands decreased from 797,748 equity shares to 792,479 equity shares.
