Shares of Idea Cellular closed at Rs 56.50 a piece, up 7.31% on the BSE on Tuesday.

A day before, Vodafone and Idea paid the DoTRsRs3926.34 crore in cash and bank guarantee of Rs3322.44 crore respectively, that was sought as a key condition for approving their merger, thereby clearing the final obstacle in the largest M&A in the sector which will create India's biggest carrier.
The final nod from the DoT is expected in

few days. Idea, in the letter, highlighted that any delay in approval would impact its 430 million subscribers of the merged entity and "severely disadvantage "the joint entity in servicing the large financial gross debt of over Rs1,25,000 crore, including the Rs90,000 crore owed to the government for various spectrum auctions.
