



# 8K Miles FY18 Gross Revenues grew 62% YoY and EBITDA up by 61% YoY

## **Highlights of the Results:**

- Gross Revenues grew to 858 crores, an increase of 62% YoY
- EBITDA grew to 300 crores, an increase of 61% YoY
- Net profit after minority interest grew to 172 crores, up by 64% YoY

"As the fiscal year started, we had set out a clear strategy to increase the revenue from existing customers, acquire new regulated enterprise customers, increase our recurring revenue portion, extend our footprint in other geographies and enhance our cloud offerings. Additionally, given our direction to increase the recurring revenue business, we constantly strive to enhance the various security standards and towards this, we are pleased that we have been recognized as Amazon's audited Nexgen MSP for the 3<sup>rd</sup> year in a row - uniquely positioning us to increase our recurring revenue in the coming years" said Mr. Suresh Venkatachari, Chairman and Managing Director, 8K Miles Software Services Limited.

"Large pharmaceuticals are starting to build new business initiatives on the Cloud using new emerging technologies such as AI/ML, IoT, Analytics, and Blockchain. "As Medicaid/Medicare funding is going down, small community hospitals and acute care hospitals are lacking enough funding to leverage big EHRs or latest technologies and new innovations to provide efficient and stable healthcare IT environment. Only way out is to become part of bigger health systems which may not be an ideal outcome for smaller hospitals. Alternatively, using common Cloud hosted services and applications could avoid such a need to merge with bigger hospitals and allow them to continue to be independent. These efforts of moving EHRs to cloud in a common hosted IT environment (public or private) can immediately bring down costs at the same time offer access to new applications/services to care continuum and delivery." said Mr. Lena Kannappan, COO of 8K Miles Software Services.
