

government why this product had not been exempt from GST when items such as binds, sindoor and kajal were.

"The proposal before the Council will be to reduce the rate to five per cent for sanitary napkins; reducing it to nil will deprive domestic manufacturers from input tax credit.

That will put them at a disadvantage as should not be any distinction. In no other GST regime anywhere in the world has there been a distinction between normal books and e-books," said Pratik Jain, partner at consultancy PwC India.

The Council will also take forward the issue of return simplification, approved by it at the earlier meeting.

"It is essential to simplify returns and provide staggered timelines for return filing," said M S Mani, partner at consultants Deloitte India.
