Combined Scrutinizer Report on Voting through Postal Ballot and Remote E-voting

Sir,

<u>Ref: Scrutinizer's Report on voting through Postal Ballot including voting through</u> <u>electronic means in terms of Section 110 of the Companies Act, 2013 read with Rule 22 of</u> the Companies (Management & Administration) Rules, 2014.

- A. Pursuant to the resolution passed by the Board of Directors of Forbes & CompanyLimited (hereinafter referred as "the Company") on 28th May, 2018,I,Makarand M. Joshi, Partner of M/s. Makarand M. Joshi & Co., Practicing Company Secretaries, have been appointed as a Scrutinizer to receive, process and scrutinize the postal ballot process in respect of the Special Resolution set out in the Postal Ballot Notice dated 28th May, 2018 ("Notice")
- **B.** Members approval was sought for the special business i.e. Authority to increase the Limits under Section 186 of the Companies Act, 2013 for Inter-Corporate Loans, Investments, Guarantees and Security
- **C.** As required under Section 110 of the Companies Act, 2013 read with Companies (Management and Administration) Rules, 2014, the Company completed dispatch of Notice along explanatory statement and postal ballot form on June 13, 2018.
- **D.** The voting period commenced on14thJune, 2018 (09:00 a.m. IST) and ended on 13thJuly, 2018 (05:00 p.m. IST)for voting through physical postal ballot form as well as through e-voting.
- E. The remote e-voting facility was provided byNational Securities Depository Limited ("NSDL")
- **F.** Particulars of postal ballot forms received including the votes cast through remote evoting have been entered in the Register separately maintained for the purpose.
- **G.** The physical postal ballot forms were kept under safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.

- **H.** The e-voting were unblocked at 5:00 p.m. on 13th July, 2018 and the e-voting summary statement was downloaded from e-voting website of NSDL.
- **I.** All ballot forms received/ votes cast up to 5:00 p.m. on13th July, 2018 being the last date and time fixed by the Company for said purpose were considered for scrutiny.
- **J.** I did not find any defaced or mutilated ballot form and all the invalid postal ballot forms were marked and segregated.
