# It's been like a dream so far: India's golden girl Hima Das

"I am living a dream", said Hima Das as she tried to put in words her remarkable journey from being a stubborn footballer in a non-script Assam village to becoming the first Indian woman world champion in athletics.

The 18-year-old Das, daughter of farmer parents at Kandhumari village in Nagaon district, has become the toast of the nation after she won a gold at the IAAF World U-20 Athletics Championships in Finland on Thursday.

She is also the first Indian—male or female—to have won a gold in a track event at the world level. She

joined Neeraj Chopra who won a gold in javelin—a field event—in the IAAF World U-20 Championships in the last edition in 2016 in Poland.

Her father Ronjit Das has a 2 bigha (0.4 acres) plot of land and her mother Jumali is a housewife. The small piece of land was the only source of income for a family of six. "I know my family's condition and how we struggled. But the Almighty has something for everybody. I am a positive person and I

want to look ahead in life and do something for my parents and for the country," Das said from Tampere in Finland on Friday.

"But it has been like a dream so far. I am now a world junior champion," she added.

Das is the eldest of four siblings. She has three younger sisters and a younger brother. "She is very stubborn, if she wants to do something she will not listen to anybody but she will do it with aplomb. She is a strong girl and that is why she is

coming up to achieve something. I hope she will do something for the country," her father Ronjit said from his village in Assam.

Das, though, is not thinking too far ahead and wants to just run faster. "I don't go out on the track thinking that I will win a medal. What I think is about running faster and faster and I believe that will translate into medals," she said.

**AFI apologise for tweet**

The Athletics Federation (AFI) of India on Saturday put its foot in the mouth when it referred to Hima Das' "not so fluent english" after her blazing run, attracting the ire of fans which forced the governing body to issue an apology in haste

Hindi.

"#HimaDas speaking to media after her SF win at #iaaf tampere2018 @iaaforg Not so fluent in English but she gave her best there too. So proud of u #HimaDas Keep rocking & yeah, try ur best in final!" the AFI wrote on its twitter handle.

The severe backlash prompted the AFI to issue a clarification. "We apologise to the country if our tweet hurt sentiments. We merely wanted to show that Hima is fearless whether on the track or outside. Despite being from a small village, she spoke freely with the foreign media. We apologise again to those who were offended," translated a tweet which was posted in Hindi by the AFI.

### Elevanil Valarivan wins gold in junior shooting meet

**NEW DELHI:** Young Indian shooter Elevanil Valarivan on Friday claimed the women's air rifle gold medal in the 28th Meeting of Shooting Hopes junior international championship in Pizen, Czech Republic. The 18-year-old shot 250.8 in the final to get the better of Italy's Nicole Gabrielli (249.7) by 1.1 point. She had also topped the qualification with 628.0. Aleksandra Szutko of Poland won the bronze with 228.2. The other Indian shooter in the final, Shreya Agrawal finished fourth with 206.6. Also, the Indian junior men swept the three medals in the 25-metre sports pistol, with Rajkanwar Singh Sandhu winning the gold with 586, one point ahead of Vijayveer Sidhu. Udhayveer Sidhu bagged the bronze medal with 582. "It feels great but more importantly it was important to maintain the consistency of points. I am happy, that I could score as planned. These are important exposure tournaments for Asian Games and my goal is to do well there," Elevanil said after her win.

### Mohammad Kaif announces retirement from competitive cricket

**NEW DELHI:** Mohammad Kaif announced his retirement from all forms of competitive cricket on Friday, almost 12 years after he last played for the Indian team in which he stood out as much for his acrobatic fielding as for his effective lower-order batting.

The 37-year-old Kaif played 13 Tests and 125 ODIs for India and will always be remembered for his match-winning knock of 87 at the Lord's during the epic NatWest Trophy final in 2002. He finished with 7581 first class runs with 15 hundreds in 129 matches. "I'm writing to you today to announce my retirement from all forms of first-class cricket," Kaif intimated acting president CK Khanna and acting secretary Amitabh Chaudhary in an email. He was a



part of the Indian team that reached the World Cup final in South Africa. Along with Yuvraj Singh, Kaif was among the stars to emerge from the U-19 India stable after leading the Colts to a maiden Junior World Cup title in 2000. "I am retiring today as it's been 16 years since the historic NatWest Trophy win in which I was glad to play my part, and I'd like to remember that as I bow out"

# India eye series win

## Men in blue will look to continue their winning run against England

A high-on-confidence India look set to wrap up another series on the UK tour unless England find a way to tackle the marauding Kuldeep Yadav when the two teams clash in the second and penultimate ODI at Lord's here on Saturday.

It is a short turn-around from the first ODI at Trent Bridge, as also from the T20I series that finished 2-1 in India's favour earlier.

Perhaps the game was scheduled for Saturday, keeping in mind the FIFA WC final on Sunday.

But, with only a day's gap between the two matches, it hasn't worked out in England's favour who have their task cut out once again after going down by eight wickets in the series opener.

In conditions resembling those in Manchester, in terms of a dry pitch, the English batsmen failed to comprehend Kuldeep's wrist spin. Like at Old Trafford, he was also helped by the breeze blowing across the ground and gained drift, bamboozling the batsmen to pick his best figures in ODI cricket.

Unlike in the T20I series, England do not have the op-



tion of battling this phenomenon with a practice outing against the spin-bowling machine, Mervyn.

With both teams travelled to London on Friday, there might not even be enough time to sit down for some video analysis. In that light, the English batsmen will have to contend mentally with how to play Yadav on Saturday. Skipper Eoin Morgan didn't play the best shot against Yuzvendra Chahal either. Yadav outfoxed both Jonny Bairstow and Joe Root, with the latter in particular looking all at sea.

India, meanwhile, are unbeaten in the bilateral ODI series since the tour of Australia in January 2016.

They have won nine successive contests thereafter, with the 2017 Champions Trophy the only tournament where in they failed to return with a trophy.

Barring any unforeseen fitness issues, the same playing eleven could feature at Lord's. Bhuvneshwar Kumar was seen bowling at Trent

Bridge ahead of the first ODI, albeit the team management might not want to rush him back in view of sterner challenges ahead.

It will be a comfortable bus journey from Nottingham to London for the Men in Blue. In the knowledge that just six days after drawing first blood on this long tour, they now have a chance to register another serious blow to England. Wrapping up the ODIs with a 2-0 unassailable will also close the gap between the two sides in the ICC rankings. More importantly, it will hand over bragging rights to India ahead of the five-Test series.

## Thailand Open: Sindhu sails into semi-final

Olympic silver medallist PV Sindhu progressed to the women's singles semi-finals after knocking out Malaysia's Sonia Cheah in straight games at the Thailand Open World Tour Super 500 tournament on Friday.

The second seeded Indian continued her consistent performance with a 21-17, 21-13 win over World No. 35 Sonia in a 36-minute clash. The World No. 3 Indian will next face Indonesia's Gregoria Mariska Tunjung.

Sindhu was erratic initially and the result was Sonia led 11-7 at the first interval.

After the break, Sindhu slowly started dominating



the proceedings and reeled off five points to lead 13-12.

The Indian started putting pressure on the Malaysian with her attacking game and grabbed four game points when Sonia hit long. The Malaysian saved one game point before Sindhu sealed the first game with a smash.

### Pant shines in India A's incredible comeback win

**TAUNTON (UK):** Rishabh Pant shone with a counter-attacking 71-ball 67 as India 'A' completed an incredible five-wicket victory over West Indies 'A' in the second unofficial Test, coming back from a precarious position to clinch the series 1-0 here on Friday. Hanuma Vihari top-scored with 68 and shared a vital partnership of 136 runs for the third wicket with Kanun Nair (55) to help India 'A' to 214.

While Pant finished the job, the foundation was laid by Vihari and captain Nair on Thursday. It ensured India 'A' did not crumble despite losing two quick wickets inside the first five overs of play on the fourth and final morning. Three quick wickets for seven runs pegged India 'A' back but Pant, throwing caution to the wind, launched into the opposition attack with some explosive strokes, so typical of him, to propel his side's chase. The Delhi player was unbeaten and found the fence 11 times, and also shared 100 runs with Jayant Yadav 23.

Spinners led by Dilruwan Perera put hosts Sri Lanka in firm command of the first Test on Friday after South Africa were bowled out for 126 — their lowest Test innings in the country.

First innings centurion Dinuth Karunaratne then made a fluent 60 as the hosts ended day two on 111 for four, leading by 272 runs at the Galle International Stadium.

Angelo Mathews, on 14, and Roshan Silva, on 10, were batting at close of play after left-arm spinner Keshav Maharaj claimed three wickets for South Africa.

But it was the Sri Lankan



bowlers who starred on a dramatic day that witnessed South Africa slip to 51-6 before being bowled out for 126 in the second session of play.

The dismal effort set a new low for South Africa in Sri Lanka, worse than their 169 in Colombo in 2006. Perera

returned impressive figures of 4-46 with his off-spin, while pacesman and stand-in skipper Suranga Lakmal took three wickets.

Rangana Herath started Sri Lanka's dominance by sending back nightwatchman Maharaj early and Perera soon took crucial wickets including the dangerous Hashim Amla for 15.

Skipper Faf du Plessis made a gritty 49 and his 64-run seventh-wicket partnership with Vernon Philander, who made 18, was the best that South Africa could muster in their 54.3 overs.

Herath grabbed two wickets while left-arm wrist spinner Lakshan Sandakan claimed one.
