The voting rights of the Shareholders shall be in proportion to their shares of the paid up equity share capital of the Company as on the cut of date. The poll process shall be conducted and the consolidated Scrutinizer Report thereon will be prepared in accordance with Section 109 of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 and Listing Regulations.
