her damirar int me sort. 18 season, which is linked to a basic recovery of only 9.5%.

Therefore, the ₹20 per quintal increase will be effective only in states where average sugar recovery is below 10 %.

Welcoming the rise in FRP, Sanjay Khatal, MD, Maharashtra State Cooperative Sugar Factories Federation (MSCSSF) said that this is a welcome step since it would mean more income for farmers.

The millers, however, are seeking a hike in the Minimum Floor Price of sugar to ₹3,400 per quintal in light of the increase in FRP on the grounds that the government has not taken the overhead finance costs that plague millers.

The existing floor price is ₹2,900 per quintal. According to Khatal, it should have been ₹3,200 per quintal at the existing FRP. He said millers incur costs to the tune of ₹300 per quintal as the interest component and therefore this should be taken into account.

Khatal said a representation has already been made to the Centre on the issue. It now remains to be seen if the millers pay up the pending dues of the last season and the farmer bodies rise up in arms again.
