# TN not responsible for flooding in Kerala: CM

◆ SC directs State govt to ensure water level at Mullaiperiyar is maintained at 139 ft

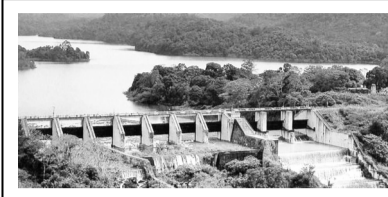

Chennai, Aug 24:

'The release of water from Mullaiperiyar dam was not the cause for floods in Kerala. Their government is raising false allegations to make us reduce the water level of Mullaiperiyar dam below 142 feet,' Chief Minister Edappadi K Palaniswami said today after Kerala filed a petition in the Supreme Court accusing its southern neighbour as the cause for the flooding in districts like Idukki near the Periyar river.

'There is no truth in Kerala government's petition,' the Chief Minister said, escalating the blame game after Kerala first accused Tamilnadu saying that flooding was triggered by the sudden release of water from the Mullaiperiyar dam.

Blaming Kerala government's inefficiency as the sole cause for flooding, Palaniswami said, 'The excess water released by the Kerala



government from multiple dams at the same time is the reason for flooding.'

The Tamilnadu government also filed a reply petition today in the Supreme Court supporting statements made by the Chief Minister.

However, a bench of Chief Justice Dipak Misra and Justices A M Khanwilkar and D Y Chandrachud considered the Centre's submission that the sub-committee of the Mullaiperiyar dam had met on 23 August and directed the Tamilnadu government to ensure that the water level is maintained at 139 feet, which is two feet below the permissible limit fixed by the apex court. The written statement from the

Tamilnadu counsel stated, 'Tamilnadu cannot accept blame for the flooding in Kerala. Only Kerala is responsible for the flood. From 14 to 19 August, 36.28 TMC water was released by the Kerala government from Idukki and Idamalayar dams. This was the major cause for flooding.'

To augment its case, the Tamilnadu petition carried a day-to-day data of the amount of water released from Mullaiperiyar and Idukki dams. It said, 'When the water level in the Mullaiperiyar dam reached 140 feet on 15 August, 1.24 TMC water was released by us into the Idukki reservoir. But, the Kerala government

released 13.79 TMC water from Idukki dam on the same date.'

'On 16 August, we released 2 TMC water from Mullaiperiyar. But Kerala released 4.47 TMC from Idukki,' it stated

Seeking more time along with Karnataka to file its reply, the Tamilnadu government told the Supreme Court that a 'sinister drama' was being played by the Kerala government to make the Supreme Court reassess its earlier order and reduce the water storage levels of Mullaiperiyar below 142 feet.

**Next hearing on 6 September**

The Supreme Court bench made it clear that it would confine itself to the aspect of disaster management and said that the decision to lower the water limit in the dam has been taken in view of the devastating deluge in Kerala. The bench fixed the matter for hearing on 6 September and asked Kerala, Puducherry, Tamilnadu and Karnataka to file their responses in the meantime.

Bopanna and Sharan defeated Aleksander Bublik and Denis Yevseyev of Kazakhstan 6-3 6-4 in 52 minutes. Less than 20 minutes into the match, the Indians were 4-1 ahead, breaking Bublik and Yevseyev at the very first opportunity they got. In no time, the top seeds were serving for the set with a 5-3 lead and Bopanna's booming serve wrapped it up in style for them. The Kazakhs had their moments but were undone by erratic play -- a brilliant cross-court backhand winner one moment and a powerless return buried in the nets the very next minute. In contrast, Bopanna

and Sharan's easy camaraderie shone through in the match and they displayed near-perfect on-court coordination.

**Heena sizzles**

Heena Sidhu shot a near-perfect 10.8 with just three shooters left in the field but a 9.6 in the next attempt dashed her hopes of a better finish at the Jakabaring Shooting Range. Having made an incredible comeback after languishing at 13th and 17th places in the qualification stage, Heena did not look content with the eventual third-place finish as she managed to reduce the gap to a mere 0.1 between her and the gold medal. Heena shot 219.3 in the final. There was more disappointment in store for 16-year-old Manu Bhaker as the Commonwealth Games gold-medallist was eliminated at fifth place with a score of 176.2.

## Five youngsters held for assaulting cop

Chennai, Aug 24:

Five youngsters were arrested by police this morning for assaulting a policeman on Thursday.

According to police, Stalin (40), head constable with the Intelligence Department lodged a complaint against one woman and four men who assaulted him outside Central Railway Station.

The police arrested Valarmathi (23) from Salem, Arunkumar (28), a resident of Anna Nagar West, Kalimuthu (27) and Shaju Kavitha (24) from Velappan Chavadi and Manikanadan (23) from Vadapalini. The police said, the youngsters were playing Tharai Thappattai in

public while collecting relief materials for Kerala flood victims outside Central Station last evening.

Stalin who arrived at the spot began taking a video of the activity which was questioned by the group. The verbal argument turned physical and Stalin was beaten up by the group. Subsequently, he informed the Railway Protection Force (RPF) present at the station.

The RPF informed the Periamet police who came and took the group to the police station, where Stalin lodged a complaint against them.

At 1 am, they were produced before a Magistrate who sentenced them to a day's imprisonment at Puzhal jail.

## Heavy rain to hit parts of north India

New Delhi, Aug 24:

The India Meteorological Department today forecast heavy to very heavy rain at isolated places over Uttarakhand, Bihar and Sub-Himalayan West Bengal and Sikkim.

According to a report released by the weather department, heavy rain at isolated places is also expected over Himachal Pradesh, Uttar Pradesh, East Rajasthan, West Madhya Pradesh, Gangetic West Bengal, Arunachal Pradesh, Assam and Meghalaya and Nagaland, Manipur, Mizoram and Tripura.

The eastern branch of monsoon trough at mean sea level has shifted northwards and passed through Firozpur, Kathail, Meerut, HarDOI, Patna, Goalpara and thence eastwards to east Assam.

## One with nature

◆ Sixty-year-old Shiva temple is built around banyan tree

Chennai, Aug 24:

First there was a banyan tree and then came a temple. But both are now existing in harmony. That is the speciality of the Sri Bala Vinayagar Sri Balamurugan Temple on Vanniyar Street, Kodambakkam.

Situated amidst a residential area with narrow streets, the temple was built under a huge banyan tree 60 years back, says N Shankar, the priest.

'We consider the banyan tree as sacred and very important as only because of the tree, the temple itself came into being. The tree might be some 70 years old. The locals placed a Vinayaka idol under it and started worshipping it. As more and more peo-

ple came here to worship, they formed a group to raise funds and built a temple 60 years ago. It was also decided that the tree will not be disturbed. So, the sanctum sanctorums were built around it. Now, the tree is situated exactly at the centre of the temple,' he says.

The main deity here, however, is Dheerga Pureeswarar (Lord Shiva). On the left is a separate shrine for Sri Bala Vinayagar and on the right, for Sri Bala Murugan.

Between Bala Murugan and Dheerga Pureeswarar shrines, there is a small shrine for Bala Sastha (Ayyappa).

On the eastern side of the temple, there is a separate shrine for Sornambikai Devi. 'The other speciality of the temple is the way the Sornambikai deity has been sculpted. The left leg of the Ambal is in front of the other leg in a walking posture,' says priest Shankar.

Suryan and Chandran are placed at the entrance. And just near the entrance on the left, a Saibaba idol is enshrined. When asked about this, he says, 'There are a lot of Shirdi Saibaba devotees here and so they placed a Saibaba idol inside the temple during the latest consecration that happened two years ago. Apart from Saibaba, other shrines for Kaala Bairavar, Danvantri, Lakshmi Hayagreevar were constructed before the consecration.'

Behind the Shiva shrine, construction work on Lakshmi Narasimhar shrine is currently in progress. There are also other shrines for Veerabadrar, Naga Kanni and Bala Muneeswarar. Every year Aadi Krithikai is celebrated in a grand manner. This year, on 5 August, during the occasion, special poojas and abhishekams were performed for Lord Muruga. After the special alankaram and aarati, 1,000 people were provided an-nadhanam,' says Shankar.

'Aadi Pooram every year sees Goddess Sornambikai decorated with bangles and a lot of people visit the temple on these occasions. Other than Aadi festival, other special occasions include Vinayaka Chaturthi, Navaratri and Shivarathri,' he said.

Every year, on the occasion of Ayyappa Makara Jyothi, special poojas for Bala Sastha and Ganapathi homam are performed. The temple is open every day from 7.30 am to 11.30 am and 4.30 pm to 8.30 pm.
