
Key Financial Highlights: Q1 FY19 and Q1 FY18

Performance Q1 FY19 vs Q1 FY18 (YoY)

- Income from operations is at Rs. 911.44 cr (excluding GST of Rs. 111.83 cr) vs Rs. 944.35 cr
- Turnover up by 8.36% on comparable basis (i.e. including GST) of Q1 FY19 vs Q1 FY18
- EBITDA is at Rs. 107.03 cr vs Rs.106.76 cr
- EBITDA margin at 11.74% vs 11.30%
- Net Profit after tax of Rs. 63.41 cr vs Rs. 55.48 cr
- PAT up by 14.29%
- PAT growth is 1.70x income from operations growth because of reduction in finance costs i.e. Rs. 25.72 cr vs
 Rs. 32.18 cr
