PROCEEDINGS OF THE 24TH ANNUAL GENERAL MEETING OF THE COMPANY

The 24th Annual General Meeting (AGM) of the Company was held on Thursday, 02nd August, 2018 at 4.00 p.m. at the Renai Cochin, Palarivattom, Kochi, Kerala - 682 025. Mr. A P Kurian, Chairman of the Company, welcomed all the Directors and the shareholders of the Company to the 24th AGM of the Company.

The requisite quorum being present, the Chairman called the meeting to order. Mr. C J George, Managing Director, Mr. R Bupathy, Chairman of Audit Committee and Nomination & Remuneration Committee, Mr. Mahesh Vyas and Mr. Punnoose George, Directors of the Company and Mr. Sampath Ganesh, representative of BSR & Associates LLP, Statutory Auditors were present at the meeting.

The notice of the Annual General Meeting was taken as read. Thereafter, Mr. Liju K Johnson, Company Secretary read the report of the Statutory Auditor's of the Company for the year ended 31st March, 2018. The Chairman then delivered his speech to the shareholders of the Company.

The Chairman then informed that the Company had provided the facility to cast their vote electronically, on all resolutions set forth in the Notice convening the 24th Annual General Meeting of the Company. Members who were present at the AGM and had not cast their votes through remote e-voting were provided with an opportunity to cast their votes by polling paper at the venue.

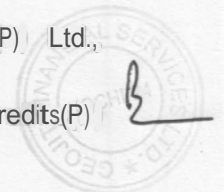
The following items of business, as per the Notice convening the 24th AGM of the Company dated 02 August, 2018 were transacted at the meeting.

Ordinary Business

1. Adoption of Financial Statements (Standalone and Consolidated), report of the Board of Directors and Auditors for the financial year ended 31st March, 2018.
2. To declare a final dividend of Rs. 2.00 per equity shares for the financial year 2017-18;
3. Re-appointment of Mr. Punnoose George, Director of the Company, who retires by rotation being eligible, offers himself for re-appointment.

Special Business

4. Appointment of Mr. Radhakrishnan Nair as Independent Director of the Company.
5. Service of Documents to members pursuant to section 20 of Companies Act, 2013 and to fix fees for serving of documents.
6. To consider obtaining Loan/Guarantee/Security from Geojit Technologies(P) Ltd., Subsidiary Company.
7. To consider granting Loan/giving Guarantee/ providing Security to Geojit Credits(P) Ltd., Subsidiary Company.



The Chairman informed that Mr. Satheesh Kumar N, Practicing Company Secretary, was appointed as the Scrutinizer for scrutinizing the poll process to be conducted at AGM in fair and transparent manner and remote e-voting process.


The members were then given adequate opportunity to give their views on the working of the Company and were also invited for any queries. The Chairman and the Managing Director promptly replied to all the queries by the members.

The shareholders were then requested to cast their vote on each resolution and complete the voting formalities. Once the voting was over, the ballot box was handed over to Mr. Satheesh Kumar N, Scrutinizer. The Chairman then announced that the voting results would be published within 48 hours of the conclusion of the Meeting and would be placed on the website of the Company at www.geojit.com as well as on the website of the e-voting service provider viz. National Securities Depository Limited. The results will also be informed to BSE and National Stock Exchange (NSE) where the Company's securities are listed.

There being no other business, the Chairman invited Mr. CJ George, Managing Director, to deliver a vote of thanks. Mr. CJ George thanked all the members for their participation and announced formal closure of the 24th Annual General Meeting of the Company.

The Meeting commenced at 4.00 PM and concluded at 5.00 PM on Thursday 02nd August, 2018.
