- The above results for the Quarter ended June 30, 2018 have been reviewed by the Audit Committee August, 2018 and thereafter approved by the Board of Directors at its meeting held on August 13, 2018.
- The above results are subject to Limited Review Report by the Statutory Auditors of the company.
- The company is operating in two segment viz. Construction and Hotel.
- The company had reached a settlement with Alchemist Asset Reconstruction Company Ltd. In settlement from State bank of India. Subsequently, after full and final payment of the settled amount in this regard no-dues from them as it relates to the amount of debt of SBI. Subsequently, the company has written off Rs. 2,556.43 lakhs as part of the settlement relating to the SBI amount and has reflected the same in the financial statements.
- The debts taken over by Alchemist Asset Reconstruction Company from Indian Overseas Bank payments are being made as per schedule and sanction terms of the restructuring, to be paid quarterly.
- Other Expenses reflects reversal of VAT to the tune of Rs.18.19 Lakhs provided in excess in the previous year.
- Provision for income tax is not made due to carry forward of unabsorbed losses of earlier years. Provision for MAT, if any, shall be provided at the end of the year on annualised basis.
- Previous year's figures have been re-grouped / re-arranged wherever necessary.
