

Avoid coercive action against Nalini in chit fund scam, SC tells ED

New Delhi, The Supreme Court on Friday restrained the Enforcement Directorate from taking coercive action against Nalini Chidambaram, wife of former Union Minister P. Chidambaram, in the multi-crore Saradha chit fund scam. A bench of Justice A.K. Sikri and Justice Ashok Bhushan also sought a response from ED and stayed a Madras High Court division bench's July 10 order that refused to quash the

summons issued to Nalini Chidambaram by the investigating agency. She has challenged the order in the apex court. Earlier, a single Judge of the High Court too had rejected her plea against the ED summons. The ED had directed her to appear as a witness in its probe into alleged money laundering in the scam, in which several key politicians were said to be involved. The agency had issued the summons on September 7, 2016, as Nalini Chidambaram's name was mentioned in a letter of Saradha scam 'mastermind' Sudipta Sen to the Central Bureau of Investigation in April 2013.

Business Brief

Availability of water will be a major issue: Prabhu

New Delhi, The availability of water is going to be a major issue for the country in future. Commerce and Industry Minister Suresh Prabhu on Thursday urged corporates to provide new technology and management expertise to address the crisis in availability of portable water during a CSR event here. According to the minister, by 2035, India will become a \$10 trillion economy, the third largest in the world and availability of water is going to be a major issue. "It should be ensured that India, the third largest economy by then, is not water stressed," a statement quoted the minister as saying.

Prabhu called for joint efforts by the government and the corporates by pulling all resources such as financial, managerial, policy framework and local resources, to address the critical challenges in sectors of water, education and healthcare. The minister decried CSR as an exemplary mode of the country for companies "who have realised that their financial success is incomplete without support of the society". He added that CSR is a reality and it makes commercial sense for corporates to invest in society.

NBCC bags contract to build India Pavilion at Dubai World Expo 2020

New Delhi, Public sector undertaking NBCC has bagged a Rs 400 crore project to construct the India Pavilion at the Dubai World Expo 2020. According to the state-run firm, the contract was awarded by the Ministry of Commerce and Industry. "The scope of work of the project includes conceptualisation, design and construction of a 4,614 square metres India Pavilion and related facilities," the firm said in a statement. Apart from showcasing India's path breaking programmes like 'Make in India', 'Smart Cities', 'Digital India', the aim of India Pavilion will also be to showcase India's strength in innovation and start-ups which are pushing the boundaries in high technology areas like artificial intelligence, fin-tech, space and green energy.
