"These techniques raise fundamental questions about the relationship between privacy and democracy, as concerns about voter surveillance could lead to disengagement with the political process. Elizabeth Denham, the British information commissioner, wrote in the report.

Last month, a report from a British Parliament committee investigating fraudulent news criticised the "relentless targeting hyper-partisan views, which play to the fears and prejudices of people, in order to influence their voting plans and their behaviour". It also called for curbs on some microtargeting. New research on how groups tied to the Kremlin exploited the technology during the 2016 presidential election in the United States is also raising concerns.

A report this week from Young Mie Kim, a professor at the University of Wisconsin-Madison, described how a Kremlin-linked
