पाक : हमले में तीन चीनी नागरिक जख्मी

कराची, 11 अगस्त (भाषा)।

पाकिस्तान के संघर्षग्रस्त बलूचिस्तान प्रांत में शनिवार को हुए एक आत्मघाती हमले में तीन चीनी नागरिकों समेत पांच लोग घायल हो गए। पुलिस ने शनिवार को यह जानकारी दी।

पुलिस ने बताया कि एक आत्मघाती हमलावर ने ईरान निर्मित पिक-अप ट्रक को चीनी इंजीनियरों को ले जा रही बस में भिड़ा दिया। ये लोग डलबैंडिन क्षेत्र में साइनडक कॉपर-गोल्ड माइन जा रहे थे। सैकड़ों चीनी नागरिक बलूचिस्तान चीन-पाकिस्तान आर्थिक गलियारे के तहत विभिन्न परियोजनाओं पर काम कर रहे हैं। चीनी नागरिक सोने और तांबे की खान में काम करते थे। नाम उजागर ना करने की शर्त पर अधिकारी ने कहा, 'उसने ईरानी कंपनी का एक पिक-अप ट्रक इस्तेमाल किया, जिसका इस्तेमाल आमतौर पर तेल ले जाने के लिए किया जाता है। हमले में ट्रक पूरी तरह क्षतिग्रस्त हो गया जबकि बस भी बुरी तरह क्षतिग्रस्त हुई है।' हमले में तीन चीनी नागरिक और फ्रंटियर कॉन्स्ट्रुबलरी के दो कर्मी घायल हो गए, जो विदेशी नागरिकों की सुरक्षा के लिए तैनात थे। घायलों को अस्पताल में भर्ती कराया गया है। उन्होंने बताया कि सुरक्षा बलों ने इलाके की घेराबंदी कर जांच शुरू कर दी है। देश में 25 जुलाई को हुए चुनाव के बाद हुआ यह पहला हमला है।
